The Board of Trustees of the Village of Stickney met in regular session on Tuesday, August 18, 2009 at 7:00 p.m. in the Stickney Village Hall, 6533 W. Pershing Road, Stickney, Illinois.

Upon the roll call, the following Trustees were present:

Trustee Schimel moved, duly seconded by Trustee Morelli, to approve the minutes of the previous regular session on Tuesday, August 4, 2009.

President O'Reilly declared the motion carried.

Trustee Lazansky moved, duly seconded by Trustee Mares that the bills, approved by the various committees of the Board, be approved for payment, and to approve warrants which authorize the Village Treasurer to draw checks to pay the bills, to be signed by the authorized signers, as provided for by the Ordinances of the Village of Stickney.

Trustee Mares moved, duly seconded by Trustee Zeedyk to approve the payment of Engineer's Payment Estimate No. 3, on Street Rehabilitation Phase 2 for \$530,807.94 to Orange Crush.

Trustee Lazansky moved, duly seconded by Trustee Zeedyk, to accept the report of the Department of Transportation, State of Illinois, and indicating Motor Fuel Tax collected for the month of July, 2009 indicating the sum of \$14,800.47.

Trustee Morelli moved, duly seconded by Trustee Mares to accept the report from the Illinois Department of Revenue for the month of May, 2009 indicating the sum of \$42,126.86.

President O'Reilly declared the motion carried.

PRESIDENT'S REPORT: We learned that with the help of Senator Viverito and Speaker Madigan that the Village received a check from the State of Illinois for the sum of \$602,000. This is half of the sum that was due us from the Grant received for the new Village Hall.

CLERKS REPORT: Information was provided concerning the Census 2010. An announcement was made concerning the September 11, Mount Auburn recognition luncheon for police and fire personnel. An interesting fact was given about 36,000 vehicles traveling daily through Stickney on Harlem Avenue. Of that, 2,950 are trucks.

#### TRUSTEE REPORTS:

Trustee Mares gave an update about his public service announcement about the drug drop-off program. He checked into a recommendation that Osco will take back old drugs. He learned that they only recycle the plastic containers and the drugs are disposed of. His concern is that the drugs will end up in the sewer system or garbage. A Parks & Recreation update was given concerning the Haunted Hayride on October 17, from 6:30 to 9:30 p.m. He was looking for volunteers. He noted that actors were needed. Contact should be made through the Parks & Recreation department.

Trustee Morelli moved to accept the Treasurer's Report for the month of June 2009, duly seconded by Lazansky.

President O'Reilly declared the motion carried.

Trustee Schimel gave an update on the housing report. The house located at 4207 Gunderson was demolished by the banker. We will be going after the legal fees. There is some dispute over that. It will soon be up for sale. Dave Schmidt made the final inspection at 3924 Grove. This is where there were previously two houses on the lot. The house on the front was condemned and demolished. Everything was then reverted to single family. There have been a couple of offers on this. At the house located at 3913 Home the judge issued an order to demolish the home and also recover all our legal fees. We have a 30-day-window to start the demolition. The thirty-day-window expired yesterday. The demolition and asbestos abatement will commence on the 24<sup>th</sup>. There is a home located at 6944 40<sup>th</sup> Street. The banker has agreed to demolish it. There is a sale pending on this. He referred to the Coyote Club demolition order and the 90-day-window to demolish it. That was two years ago. A change is now being applied to future demolition orders such as 6944 40<sup>th</sup> Street. If they haven't satisfied the demolition within the time ordered, there will be a \$250

per day fine applied. The Coyote Club is the only one that is outstanding. Attorney Steve Adatto explained that the attorney's are fighting the judgment. The judge does not want to take away property and demolish it without due process in court. We will be back in court within 21 days. Everything should be filed by then. The judge could give a trial date if needed. This could cause more fees passed on to the owner. Trustee Schimel warned that there are easily another five homes that could take the place of this current list that could be demolished.

Trustee Zeedyk informed us that the stump removal is almost completed. A couple of additional stumps were discovered. A woman in the audience notified the Trustee of one on her property located at 6423 41<sup>st</sup>.

#### DEPARTMENT REPORTS:

Deputy Fire Chief John Babinec gave a special report on the E-911 upgrade. He provided a lengthy history of the 1990 inception until today. The agreement with the vendor and the Village was signed on August 18. Trustee Lazansky questioned the availability and compatibility of parts into the future. Babinec responded that they will be.

Police Chief Joe Kretch reported that they have just completed an upgrade on the police department server. It has nothing to do with the 911 system. It is used as a writing system and was at capacity and ran out of hard-drive space. The age was also a factor. The two black and white squad cars are now cruising the neighborhood.

Public Works Supervisor Joe Lopez informed us that Bluder's Tree Service will be working in the village to cut the tall tree branches that public works couldn't reach.

#### AUDIENCE QUESTIONS:

Penny Gibas of 4425 Wisconsin remarked on better patrolling of Haley Park. She also questioned the older youths from Cicero and Berwyn that frequent the park monopolizing it. Mrs. Gibas had concerns over parents not allowing their 9-10 year olds to go to the park because of the situation. Someone has checked the Berwyn and Cicero vehicle stickers of the cars. Trustee Mares remarked that the court is open to the public. He suggested that a sign could be put up saying that if there are people waiting, the court should be split up to play two games. Mrs. Gibas questioned the *Life Newspaper* article pertaining to graffiti on garages. She wanted to know if it has been taken care of and if someone was arrested for it. President O'Reilly remarked on the first news article that appeared since our administration and that the graffiti was removed within the ordinance mandated 10 days. There are no leads at this time of who did this. Mrs. Gibas went on to ask if someone was arrested at recent fight which included stabbing and if it was gang related. Police Chief Kretch replied that four youths were arrested and it was not gang related.

Rick Kucera of 4342 S. Wenonah wanted to know if the village web site is being updated. He suggested going to the local school computer clubs for assistance. President O'Reilly responded that we have someone working on it. Mr. Kucera addressed an ongoing issue with a neighbor with barking dogs. Chief Kretch suggested that he call and ask to talk to a supervisor if he is not happy with the response. Mr. Kucera then suggested that we start up the Neighborhood Watch program again.

ORDINANCE NO. 2009-19

AN ORDINANCE AMENDING CHAPTER 14, "MOTOR VEHICLES AND TRAFFIC", OF THE ORDINANCES OF THE VILLAGE OF STICKNEY, ILLINOIS BY REVISING ARTICLE I, SECTION 14-8, "SNOW EMERGENCIES".

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, A HOME RULE UNIT OF GOVERNMENT AS FOLLOWS:

**WHEREAS**, the Village of Stickney (the "Village") is a home rule municipality in accordance with the Constitution of the State of Illinois of 1970; and

**WHEREAS**, the Village of Stickney seeks to maintain the safety and appearance of the streets and roadways throughout the Village; and

**WHEREAS**, the Village of Stickney maintains certain regulations of the streets and sidewalks and enforces certain regulations of the State of Illinois; and

**WHEREAS**, the President and Board of Trustees of the Village of Stickney seek to change the rules, procedures, fines.

**RESOLVE:** NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEE OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS.

**Section 1. Recitals.** The facts and statements contained in the preambles to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

**Section 2. Adoption.** Chapter 14 Article I, Section 14-8, paragraph (a), (b) and (g), of the Municipal Code of the Village of Stickney shall be amended to read as follows:

**Sec. 14-8. Snow Emergencies**

(a) A snow emergency shall be declared by the Village President after consultation with his department heads or in their absence, their designee, in the event that six inches of snow has accumulated and the National Weather Service predicts additional snowfall for the area. Such snow emergency shall remain in effect until it no longer exists by declaration of the Village President after consultation with his department heads or their designees.

(b) To facilitate the snowplowing of and snow removal from public thoroughfares within the village, it shall be unlawful during a declared snow emergency for any person to stand, park, or leave unattended a motor vehicle upon the following described streets and parts thereof as set forth in this subsection (b) beginning eight hours after a snow emergency is declared to exist, and shall remain in effect until the snow emergency is declared no longer to exist.

- (1) On odd-numbered days from 8:00 a.m. to 11:00 p.m.
  - a. On the south side of all streets and public thoroughfares extending in a generally easterly and westerly direction, including off-street parking, except for Pershing Road;
  - b. On the east side of all streets and public thoroughfares extending in a generally northerly and southerly direction including off-street parking.
- (2) On even-numbered days from 8:00 a.m. to 11:00 p.m.
  - a. On the north side of all streets and public thoroughfares extending in a generally easterly and westerly direction, including off-street parking, except for Pershing Road.

- b. On the west side of all streets and public thoroughfares extending in a generally northerly and southerly direction, including off-street parking.
- (3) It shall be unlawful to park any vehicle when snowfall is over six (6) inches as follows:
- a. On Pershing Road from 12:00 a.m. to 5:00 a.m. pending removal.

(g) Any person who violates any provision of this section shall be guilty of an offense punishable by a fine of not less than \$50.00 nor more than \$200.00 for each offense.

**Section 3. Home Rule.** This ordinance is enacted under the Home Rule powers of the Village as set forth in the Constitution and laws of the State of Illinois.

**Section 4. Effective Date.** This Ordinance shall be in full force and effect after its passage, approval and publication in the manner provided by law.

**Section 5. Conflicts.** This Ordinance supersedes all ordinances or parts of ordinances directly conflicting with the terms and provisions contained herein, but only to the extent of such conflict.

**Section 6. Severability.** If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.

**Section 7. Certification and Publication.** The Village Clerk of the Village of Stickney shall certify to the adoption of this Ordinance and cause the same to be published in pamphlet form.

AN ORDINANCE AMENDING CHAPTER 14, "MOTOR VEHICLES AND TRAFFIC", OF THE ORDINANCES OF THE VILLAGE OF STICKNEY, ILLINOIS BY REVISING ARTICLE III, DIVISION 7, STOPPING, STANDING AND PARKING, SECTION 14-147, "PARKING AFTER SNOWFALLS" AND ADDING SECTION 14-147.1, "CLEARING OF SNOW IN ALLEYS".

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, A HOME RULE UNIT OF GOVERNMENT AS FOLLOWS:

**WHEREAS**, the Village of Stickney (the "Village") is a home rule municipality in accordance with the Constitution of the State of Illinois of 1970; and

**WHEREAS**, the Village of Stickney seeks to maintain the safety and appearance of the streets and roadways throughout the Village; and

**WHEREAS**, the Village of Stickney maintains certain regulations of the streets and sidewalks and enforces certain regulations of the State of Illinois; and

**WHEREAS**, the President and Board of Trustees of the Village of Stickney seek to change the rules, procedures, fines.

**RESOLVED:** NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEE OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS.

**Section 1. Recitals.** The facts and statements contained in the preambles to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

**Section 2. Adoption.** Chapter 14, Article III, Division 7, Section 14-147 shall be amended and Section 14-147.1 of the Municipal Code of the Village of Stickney shall be added to read as follows:

**Sec. 14-147. Parking after snowfalls.**

(a) It shall be unlawful to park any vehicle when snowfall is over two (2) inches as follows:

- (1) On odd-numbered days from 8:00 a.m. to 11:00 p.m.
  - a. On the south side of all streets and public thoroughfares extending in a generally easterly and westerly direction, including off-street parking, except for Pershing Road;
  - b. On the east side of all streets and public thoroughfares extending in a generally northerly and southerly direction including off-street parking.
- (2) On even-numbered days from 8:00 a.m. to 11:00 p.m.
  - a. On the north side of all streets and public thoroughfares extending in a generally easterly and westerly direction, including off-street parking, except for Pershing Road.
  - b. On the west side of all streets and public thoroughfares extending in a generally northerly and southerly direction, including off-street parking.

(b) It shall be unlawful to park any vehicle when snowfall is over ~~six~~ (6) inches as follows:

- (1) On Pershing Road from 12:00 a.m. to 5:00 a.m. pending removal.

**Sec. 14-147.1. Clearing of Snow in Alleys**

In the event of a snowfall greater than six (6) inches, the middle of all alleys will be cleared of snow, permitted if all of the streets have been cleared of snow first. This will begin at Ridgeland Avenue, and continue throughout the Village in a westerly direction until all alleys have been cleared.

**Section 3. Home Rule.** This ordinance is enacted under the Home Rule powers of the Village as set forth in the Constitution and laws of the State of Illinois.

**Section 4. Effective Date.** This Ordinance shall be in full force and effect after its passage, approval and publication in the manner provided by law.

**Section 5. Conflicts.** This Ordinance supersedes all ordinances or parts of ordinances directly conflicting with the terms and provisions contained herein, but only to the extent of such conflict.

**Section 6. Severability.** If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.

**Section 7. Certification and Publication.** The Village Clerk of the Village of Stickney shall certify to the adoption of this Ordinance and cause the same to be published in pamphlet form.



AN ORDINANCE AMENDING CHAPTER 14, "MOTOR VEHICLES AND TRAFFIC", OF THE ORDINANCES OF THE VILLAGE OF STICKNEY, ILLINOIS BY REVISING DIVISION 7, STOPPING, STANDING AND PARKING, SECTION 14-148, "PARKING DURING STREET CLEANING OPERATIONS".

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, A HOME RULE UNIT OF GOVERNMENT AS FOLLOWS:

**WHEREAS**, the Village of Stickney (the "Village") is a home rule municipality in accordance with the Constitution of the State of Illinois of 1970; and

**WHEREAS**, the Village of Stickney seeks to maintain the safety and appearance of the streets and roadways throughout the Village; and

**WHEREAS**, the Village of Stickney maintains certain regulations of the streets and sidewalks and enforces certain regulations of the State of Illinois; and

**WHEREAS**, the President and Board of Trustees of the Village of Stickney seek to change the rules, procedures, and fines.

**RESOVLED**: NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEE OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS.

**Section 1. Recitals.** The facts and statements contained in the preambles to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

**Section 2. Adoption.** Chapter 14, Article III, Division 7, Section 14-148 of the Municipal Code of the Village of Stickney shall be amended to read as follows:

**Sec. 14-148. Parking during street cleaning operations.**

(a) It shall be unlawful to park any vehicle on any public street or portion thereof in the Village at any time from January 1 to December 31, when such streets are being cleaned as follows:

(1) On Thursdays between 7:00 a.m. and 7:00 p.m.

- a. On the north side of all streets and public through fares extending in a general easterly and westerly direction; and
- b. On the west side of all streets and public through fares extending in a generally northerly and southerly direction.

(2) On Fridays between 7:00 a.m. and 7:00 p.m.

- a. On the south side of all streets and public through fares extending in a generally easterly and westerly direction; and,
- b. On the east side of all street and public through fares extending in a generally northerly and southerly direction.

(b) It shall be unlawful to park any vehicle on Pershing Road or Portion thereof in the Village at anytime from January 1, through December 31 when Pershing Road is being cleaned as follows:

(1) On Fridays between 5:00 a.m. and 7:00 a.m.

**Section 3. Home Rule.** This ordinance is enacted under the Home Rule powers of the Village as set forth in the Constitution and laws of the State of Illinois.

**Section 4. Effective Date.** This Ordinance shall be in full force and effect after its passage, approval and publication in the manner provided by law.

**Section 5. Conflicts.** This Ordinance supersedes all ordinances or parts of ordinances directly conflicting with the terms and provisions contained herein, but only to the extent of such conflict.

**Section 6. Severability.** If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.

**Section 7. Certification and Publication.** The Village Clerk of the Village of Stickney shall certify to the adoption of this Ordinance and cause the same to be published in pamphlet form.



ORDINANCE NO. 2009-22

AN ORDINANCE AMENDING ORDINANCES OF THE VILLAGE OF STICKNEY, ILLINOIS BY REVISING CHAPTER 70, SOLID WASTE, ARTICLE II, REFUSE, RECYCLABLES AND YARD WASTE, DIVISION 3, RESIDENTIAL SOLID WASTE AND RECYCLING COLLECTION REGULATIONS, SECTION 70-88, 70-89, "YARD WASTE AND LEAF REMOVAL" AND SECTION 70-90 "PENALTY FOR VIOLATION OF SECTION PROVISIONS".

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, A HOME RULE UNIT OF GOVERNMENT AS FOLLOWS:

**WHEREAS**, the Village of Stickney (the "Village") is a home rule municipality in accordance with the Constitution of the State of Illinois of 1970; and

**WHEREAS**, the Village of Stickney seeks to maintain the health and appearance of the Village; and enforces certain regulations for the Village of Stickney and the State of Illinois; and

**WHEREAS**, the President and Board of Trustees of the Village of Stickney seek to change the rules, procedures, and fines.

**RESOLVED:** NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEE OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS.

**Section 1. Recitals.** The facts and statements contained in the preambles to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

**Section 2. Adoption.** Chapter 70, Article II, Division 3, Section 70-88 and Section 70-89 shall be amended and Section 70-90 shall be reserved of the Municipal Code of the Village of Stickney shall be amended to read as follows:

**Sec. 70-88 Yard Waste.**

- (a) The Village of Stickney Solid Waste Practices and Procedures shall apply to all yard waste, vegetation, including leaves and will govern their waste disposal. The Village of Stickney Solid Waste Practices and Procedures handout shall be available to all residents of the Village at the Village hall. The Village shall not provide disposal services for excessive yard waste. Excessive yard waste shall mean any waste that is not disposed of in accordance with the Practices and Procedures. Yard waste including leaves, shall be placed in either a paper lawn/leaf bag or a rigid container not to exceed 35 gallons or 50 pounds in weight.
- (b) It shall be unlawful to burn leaves or any other yard waste within the Village.
- (c) It shall be unlawful to place any leaves or other yard waste into the street without being in a sanctioned container.

**Sec. 70-89 Penalty for violation of section provisions.**

Any person found guilty of violating any of the provisions of this section or the Village of Stickney Practices and Procedures, upon conviction thereof, shall be issued a fine of not less than \$50.00 nor more than \$200.00.



Each failure to comply with the provisions of the section or the Village of Stickney Solid Waste Practices and Procedures with respect to each person shall be considered a separate offense. A separate and distinct offense shall be regarded as committed each day during or on which such person shall continue or permit any such violation.

**Sec. 70-90. Reserved**

**Section 3. Home Rule.** This ordinance is enacted under the Home Rule powers of the Village as set forth in the Constitution and laws of the State of Illinois.

**Section 4. Effective Date.** This Ordinance shall be in full force and effect after its passage, approval and publication in the manner provided by law.

**Section 6. Severability.** If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.

**Section 7. Certification and Publication.** The Village Clerk of the Village of Stickney shall certify to the adoption of this Ordinance and cause the same to be published in pamphlet form.





ORDINANCE NO. 2009-23

AN ORDINANCE AMENDING CHAPTER 14, "MOTOR VEHICLES AND TRAFFIC" , OF THE ORDINANCES OF THE VILLAGE OF STICKNEY, ILLINOIS BY REVISING ARTICLE III, DIVISION 7, "STOPPING, STANDING AND PARKING."

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, A HOME RULE UNIT OF GOVERNMENT AS FOLLOWS:

**WHEREAS**, the Village of Stickney (the "Village") is a home rule municipality in accordance with the Constitution of the State of Illinois of 1970; and

**WHEREAS**, THE Village of Stickney seeks to maintain the safety and appearance of the streets and roadways throughout the Village; and

**WHEREAS**, the Village of Stickney maintains certain regulations of the streets and sidewalks and enforces certain regulations of the State of Illinois; and

**WHEREAS**, the President and Board of Trustees of the Village of Stickney seek to raise the administrative fee charged for violations and penalties that are involved in prohibited activities to be equal to the rate charged in the village's surrounding communities; and

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEE OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS.

**Section 1. Recitals.** The facts and statements contained in the preambles to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

**Section 2. Adoption.** Chapter 14 Article III, Division 7, Sec. 14-163 of the Municipal Code of the Village of Stickney shall be amended to read as follows:

**Sec. 14-163. Violations and penalties**

- (a) Any person receiving an initial notice of violation of an ordinance of the village prohibiting the parking of vehicles in a designated area or restricting the length of time such vehicles may be parked there, may settle and pay the claim against him or her for a such illegal parking by paying to the village the sum of \$50.00 on or before the date payment is due as provided in such notice.
- (b) In the event that the person to whom said ticket is issued fails to pay said violation within the time specified in the ticket, shall appear and defend such violation at the date set forth on said notice at the village adjudication hearing.
- (c) In the event payment is not made nor an appearance made by the person issued said violation, the hearing officer shall determine and establish a fine to be paid, but not to exceed the sum of \$500.00 for any one violation.
- (d) Appeal from any judgment entered by the administrative hearing officer shall be in accordance with the applicable ordinances of the Village of Stickney and the Illinois Compiled Statutes.

**Section 3. Home Rule.** This ordinance is enacted under the Home Rule powers of the Village as set forth in the Constitution and laws of the State of Illinois.

**Section 4. Effective Date.** This Ordinance shall be in full force and effect after its passage, approval and publication in the manner provided by law.


