The Board of Trustees of the Village of Stickney met in regular session on Wednesday, November 6, 2024, at 7:04 p.m. in the boardroom located at 6533 W. Pershing Road, Stickney, Illinois.

She was our first pregnant police officer. Whatever it is, she can serve as a guardian for our other female officers to achieve. Something for them to aspire to.
