CLERKS REPORT: A reminder was given that the next regular scheduled board meeting was changed to November 3, from the original date of Wednesday, November 4. The change was due to no elections taking place on Tuesday, November 3.

The clerk continued with her report by giving information concerning the Census 2010.

TRUSTEE REPORTS:

Trustee Lazansky gave the promised information concerning the Vietnam Moving Wall location and dates in Westchester. He also informed us of the Midway Noise Compatibility meeting that will take place this week. He will have a report for the next board meeting.

Trustee Mares reported that the Haunted Hay Ride had a nice turn out. He thanked the numerous volunteers who helped.

Trustee Morelli told us of a program on October30, from 5:30 to 8:30 at the Library. It is called, Tweens Fright Night. Movies and games will be included. Trustee Morelli remarked on the newsletter and especially pointed out the work done by Police Telecommunicator, Brent Tureson and his skills in entering all the information in the newsletter format.

Trustee Walik provided information on the up-coming closing of the railroad tracks located on Cicero Avenue near 40th Street. Expect the closing from November 2 to 8. Central Avenue is expected to be the alternate route. Truck traffic should be heavy. Trustee Walik reminded the people of donations for our troops. Flyers with suggested items are being handed out to the homes. The Village Hall, Police Station and Public Works are drop off locations. The donation suggestions were made by police and fire personnel. Donations are due by November 19.

DEPARTMENT REPORTS:

Fire Chief Larry Meyer reported that the fire-prevention programs were completed at the Village's schools. The new fire engine is in and all the necessary equipment is being loaded onto it. The old fire engine has been sold. It was moved to Arkansas.

Police Chief Joe Kretch gave information about a scam that took place in the Village last week. It involved an elderly man who had a Hispanic male come to his door and claim he was a Village Trustee and said he worked for Public Works. He asked entry to check his water pipes. The elderly man said the Hispanic man walked throughout the house opening valves pretending that he was checking the water. He asked the elderly man for money which was given to him. Later the elderly man found that he was missing \$250. Chief Kretch notified people that if someone from the Village comes to your home, which is rarely done, they have identification either clipped to their shirt or around their neck. If someone is skeptical, just call the police. The police will always check on any calls of this nature. In addition, Chief Kretch provided information about the Police Telecommunication expert, Brent Tureson, being in Springfield this week at a 911 seminar. We should expect a report on what he has learned at the next meeting.

Treasurer, Kurt Kasnicka reported that the Cook County tax bills will be out the first of November with the due date of December 1. He continued to say that the Cook County tax rate looks to be down but it will be off-set by the increase in the assessed evaluation that has gone up overall.

AUDIENCE QUESTIONS:

Penny Gibas of 4425 Wisconsin remarked about the newsletter. Mrs. Gibas asked about the six new auxiliary police and the training of them. She also requested information on the donations to the troops. Lastly she wanted to know if the seniors at their clubs have been informed of the scam. They have been informed.

Jim Gibas is a resident of Harvey but stays at his mother's house. He wondered who checks on the park equipment. He noted some graffiti on the equipment at the park located on Oak Park Avenue. Trustee Mares explained the routine that is done to look for and resolve graffiti in the parks.

Doris Helebrandt of 6528 41st Street commented on the newsletter and in particular the information about the plowing of snow in the alleys. She wanted to make note of the residents who clear the area around their homes prior to the plowing. She requested that the Village not plow and dump snow from another source on their cleaned garage area.

Bea Callahan, 4126 Grove, commented on the newsletter. Mrs. Callahan also suggested that the times for Trick or Treating be included in the next fall newsletter.
