The Board of Trustees of the Village of Stickney met in regular session on Tuesday, June 7, 2022, at 7:01 p.m.

Upon the roll call, the following Trustees were present: Trustees White, Savopoulos, Milenkovic, Torres, Kapolnek and Hrejsa

Trustee Savopoulos made a motion to elect Trustee White as President Pro Tempore for the Regularly Scheduled Meeting of the Board of Trustees for the Village of Stickney. Motion was seconded by Trustee Kapolnek.

Trustee Torres, duly seconded by Trustee Hrejsa to Pass and Approve Ordinance No. 2022-12 "An Ordinance Authorizing the disposal of personal property for the Police Department of the Village of Stickney, Cook County, State of Illinois.

#### Motion carried.

Trustee Milenkovic, duly seconded by Trustee Savopoulos to Pass and Approve Ordinance No. 2022-13 "An Ordinance to establish an administrative procedure for assessing and determining claims under the public safety benefits act for the Village of Stickney, Cook County, State of Illinois.

In addition, Attorney Jessica Feese explained that this is a code amendment which establishes a procedure called PSEBA – an act that Illinois has that is related to Police Officers and Fire Fighters in the event there is a catastrophic injury while on duty while responding to an emergency, if they are deceased or survive but unable to work, they and their family dependents are entitled to certain health insurance benefits thru the Village. This is a nice benefit, and it also allows the Village to have some sort of control over the process. There hasn't been anything on the books before and will be great for our Police Officers and Fire Fighters.

Trustee Savopoulos, duly seconded by Trustee Kapolnek to Pass and Approve Resolution No. 10-2022 "A Resolution waiving bidding requirements for certain emergency repairs for the Village of Stickney, Cook County, State of Illinois."

In addition, Attorney Jessica Feese explained that the Village received a memo from the Village Engineer regarding the water main on East Avenue between 43<sup>rd</sup> and 41<sup>st</sup> near the school that is in bad shape and in need of repair ideally before school starts. If something were to happen with the water main during the school year, the school would most likely have to be shut down for the repair. To avoid this happening, we are waiving the formal bidding process to accelerate the start of the repair. The Village will attempt to get multiple bids/quotes to get the best possible bid.

<u>MAYOR'S REPORT</u>: Trustee Jeff White Mayor Pro Tempore reported for Mayor Walik. He said the Mayor can't be here tonight but he would like to thank all departments for all their hard during the storm. Everyone worked very hard and tirelessly the whole week. The Mayor was even out helping with the clean-up.

<u>Trustee Torres</u> reported that the Village will have additional hours this Saturday, June 25 from 9am-3pm. Last day of stickers sales will be next Thursday, June 30<sup>th</sup>. Make sure you have your stickers on by midnight July 1, because the police will be ticketing. If you buy a sticker but forget to display it, you are eligible to get a ticket, so make sure you put it on your windshield.

## **DEPARTMENT REPORTS:**

<u>Fire Chief Jeff Boyajian:</u> Reported that tomorrow the new ambulance will be put in to service and will be on the streets. You'll see it, and can't miss it, it's red, black with gold lettering. We finally got the state to come out and certify and the village paid the \$26 licensing fee. Last week during the storm, we took 55 calls in the first 4 hours, mostly trees down, we had one garage fire where an electrical line hit the medal door. No one was hurt so I was happy about that. Public Works did a great job. Almost everything was cleaned up by Friday.

<u>Police Chief James Sassetti</u>: Reported that the Stickney Police Department is participating in a program which will provide extra police officers on the street between now and the 5<sup>th</sup> of July and will be detecting and arresting impaired drivers.

<u>Public Work's Supervisor Joe Lopez</u>: Reported that the storm did do a lot of damage in the village with downed trees and tree branches. His department worked very hard getting everything cleaned up. By last Thursday the town was about 85% complete. They're still working on cleaning up "hangers" in the trees, but they are hard to spot because the fullness of the trees so they will address on an as needed basis.

# Public Comment:

Resident wanted to thank the public service departments and their excellent work during the storm last week. He said that it was good to see even neighbors on his block that don't talk to each other, they all pitched in and helped remove branches. It was good to see. He also wanted to thank the Police department for helping out with the procession with St. Leonard and St. Pius on Sunday while they walked on the street all the way from Berwyn and helped them cross Pershing Rd. and walked down Oak Park Avenue.

Resident had a tree on her property fall in her backyard and was asking for help in getting it removed. Joe Lopez asked her if she contacted her insurance company and she said she did. but they can't help because she didn't have any property damage. She was told that because it's private property that it's her responsibility to take care of. It was decided that if she can get it cut into pieces and put it on the parkway that the Village will remove it.

Resident complained about loud music by her house at 1:00 in the morning. It's very annoying and she can't sleep. Jeff White asked her if she calls the police and she said she does but what happens is that they show up and tell them to turn down the music but as soon as they leave the music gets loud again. She asked if she could make fliers to hand out with the times. Police chief told her she could print the noise ordinance off the website so it's accurate. She was told that she can request a ticket to be given and she can appear in court to talk to the Judge about her complaint. She also complained that the street work that was done in front of the laundry mat on Pershing Rd. She said it looked terrible and she showed a picture. Joe Lopez said the work was temporary and that is has been fixed. Trustee White advised her that there is a 3-minute time limit on her comment and that she can talk to Joe Lopez after the meeting. She said ok and then had another complaint about a tree by her house that has cables running thru the middle of the trees. She was told that ComEd would handle that.

There being no further business, Trustee Savopoulos moved, duly seconded by Trustee Torres that the meeting be adjourned. Upon which the Board adopted the motion at 7:22 p.m.

#### **RESOLUTION NO. 11-2022**

# A RESOLUTION APPOINTING JAMES HREJSA TO THE BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COUNTY OF COOK, STATE OF ILLINOIS.

WHEREAS, the Village of Stickney (the "Village") is a home rule municipal corporation in accordance with Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970; and

WHEREAS, the Village has the authority to adopt ordinances and resolutions and to promulgate rules and regulations that pertain to its government and affairs, and to review, interpret and amend its ordinances, resolutions, rules, and regulations; and

**WHEREAS,** the Village President (the "President") and the Board of Trustees of the Village (the "Village Board" and with the President, the "Corporate Authorities") are committed to ensuring the health, safety, and welfare of Village residents; and

**WHEREAS,** after many years of dedicated service, Trustee Mary Hrejsa has chosen to resign from the Village Board; and

WHEREAS, the resignation of Trustee Mary Hrejsa has created a vacancy on the Village Board; and

WHEREAS, the Village Board hereby finds and declares that there exists a vacancy in the position of Trustee on the Village Board; and

WHEREAS, the President has determined that it is necessary for conducting Village business and for the effective administration of government to appoint James Hrejsa to serve as Trustee of the Village (the "Appointment") to fill the vacancy; and

**WHEREAS**, the Corporate Authorities have determined that it is necessary to accept and approve the Appointment of James Hrejsa as Trustee to the Village Board;

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, as follows:

#### ARTICLE I. IN GENERAL

#### Section 1.0 Findings.

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preambles to this Resolution are full, true, and correct and do hereby, by reference, incorporate and make them part of this Resolution as legislative findings.

#### Section 2.0 Purpose.

The purpose of this Resolution is to declare a vacancy in the position of Trustee of the Village, to appoint James Hrejsa to serve as Trustee of the Village as set forth herein, and to take all steps necessary to carry out the terms of said Appointment.

# Section 3.0 Declaration of Vacancy; Authorization.

The Corporate Authorities hereby declare that there exists a vacancy in the position of Trustee of the Village. The President, with the advice and consent of the Village Board, hereby appoints James Hrejsa to serve as a Trustee of the Village of Stickney. The President or his designee is hereby authorized and directed to take such steps as are necessary to carry out the intent of this Resolution.

#### ARTICLE II. AUTHORIZATION

#### Section 4.0 Effectiveness and Term of Appointment.

That the Appointment set forth herein is effective immediately. The Appointment shall remain effective through the unexpired term for the vacant Trustee position referenced above.

## ARTICLE III.

# HEADINGS, SAVINGS CLAUSES, PUBLICATION, EFFECTIVE DATE

# Section 5.0 Headings.

The headings of the articles, sections, paragraphs, and subparagraphs of this Resolution are inserted solely for the convenience of reference and form no substantive part of this Resolution nor should they be used in any interpretation or construction of any substantive provision of this Resolution.

#### Section 6.0 Severability.

The provisions of this Resolution are hereby declared to be severable and should any provision of this Resolution be determined to be in conflict with any law, statute, or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable, and as though not provided for herein, and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

#### Section 7.0 Superseder.

All code provisions, ordinances, resolutions, rules, and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

# Section 8.0 Publication.

A full, true and complete copy of this Resolution shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

# Section 9.0 Effective Date.

This Resolution shall be effective and in full force immediately upon passage and approval.
