The Illinois Department of Transportation is starting Phase I of preliminary engineering and environmental studies to improve I-55 from I355 to I-90/94.

A reminder was given about the November 6, 2012 election. As in the past, the clerk asked people to check on the judges they will be voting on by visiting Voteforjudges.com. This web site has multiple evaluations conducted by numerous bar associations.

There will be three referendum questions on the ballot. One of the questions is on Electric Aggregation for the Village of Stickney. You need to vote yes or no. Another question that is on the ballot is Electric Aggregation for Stickney Township. The clerk questioned the Cook County Clerk's office and voiced her opinion that this will confuse people. The Township question should not be on our ballot. This question should only be voted on by unincorporated Stickney Township.

TRUSTEES REPORT:

Trustee Horne reminded us of the Veteran's Day program on Monday, November 12. It will be on 39th and Ridgeland at 10:30 a.m. If it rains, it will be held at the American Legion. He said, "Don't forget the guys that have paid the price."


