The Clerk asked for a motion to appoint a President Pro Tem for this meeting only.

Trustee White explained that the Mayor is absent today. The Mayor had a routine doctor's appointment a few days ago. His doctor's office is at LaGrange Hospital. The Mayor was required to take a Covid test. It was negative. The next day he received a call that the test was, in fact, positive. He has no symptoms. Just to be cautious he is self-quarantining until the 9<sup>th</sup> of January.

**CLERK'S REPORT:** The Clerk supplied some facts produced by the Census people. During the year 2020 the combined revenues for property, sales and gross receipts and income tax revenue dropped from 23.79% in the first quarter, 39.003% in the second quarter and 9.55% in the third quarter of 2020.

**Police Chief James Sasseti:** The Chief reminded everyone to be aware of their surroundings. Call police if you see suspicious activity. Communities in close proximity to us have seen an increase in vehicle hijackings and other violent crimes. Stickney has had zero incidents of that. We just want to remind everyone to be aware.

**Fire Chief Jeff Boyajian:** We were informed that the film for the in-service training for their new Genesis Rescue System that the Board and the Mayor allowed us to buy will be viewed at the January 19<sup>th</sup> Board Meeting. The equipment was placed on the apparatus this afternoon. It is State-of-the-Art and is replacing equipment from 1986.

Lastly, President Pro Tem White informed people that Waste Management will be picking up natural Christmas trees this week and next on your regular garbage days.

There being no further business, Trustee Milenkovic moved, duly seconded by Trustee Savopoulos that the meeting be adjourned. Upon which the Board adopted the motion at 7:14 p.m.
