MAYOR'S REPORT: The Mayor apologized for missing the last board meeting due to bad pneumonia. Trustee Savopoulos had some minor back surgery and will be back soon. The Mayor gave the Unofficial results if the April 4, 2023 Consolidated Election for the Village Independent Party, Jeffery White 256, 34.88%; Mitchell Milenkovic 240, 32.70%; James Hrejsa 238, 32.43%; The clerk added that the total was actually one half of the total from the election in 2019. It was a poor voter turnout. The Official

results will be ready for the May 2, 2023 board meeting. The Mayor commented on the amazing response to the Easter Egg Hunt. We were reminded that the May 2, 2023 Board Meeting will be held at Saint Pius Church hall. The attorney asked that notices be given to inform people of the change a substantial time prior to the meeting. She is planning the Cinco De Mayo festivities on April 30, 2023 from 2:00-7:00 p.m. It is located at 43^{rd} and Ridgeland. An outline of the activities was given. There will be raffle prizes. The Morton College nurses will be taking blood pressure checks. It is open to everyone.

<u>Trustee Milenkovic:</u> The Tree Board and Trustee Hrejsa joined forces to prepare for Arbor Day. The celebration will be on Friday, April 28, 2023. We do this every year to keep our Tree City status.

DEPARTMENT REPORTS:

<u>Police Chief Sassetti:</u> During the month of April pursuant to the Illinois Department of Transportation Step Grant, the Stickney Police Department will have extra officers on the street as part of the "Drop and Drive" campaign. The primary focus will be trying to find violators on their phones or texting while driving. You will see an increased police presence on the street during the month of April for this purpose.

Fire Chief Jeff Boyajian: He asked people to have a safe Easter.

<u>Public Works Assistant Director Sam Alonzo:</u> Street sweeping has begun. He asked people to respect parking restrictions. The Mayor mentioned that people have contacted him to thank him for cleaning the alleys.
