CLERKS REPORT: A notice of the open meeting for bid opening was given for March 22, 2011 at 1:00 in the Village meeting room. The bids are for the street rehabilitation phase IV.

TRUSTEE REPORTS: Trustee Mares the newsletter will have park & recreation events listed. There will also be items on the web site. The Easter Egg Hunt planned date is April 23, at Haley Park at 10:00. The Memorial Day parade will be combined with the Berwyn Combined Veterans of America traveling down Oak Park Avenue. The exact date for that is still unknown.

Trustee Morelli reported on the February Fire Department activity. Calls: this includes 1 Fire & 9 Service related calls and 51 Ambulance calls, 17 automatic fire and trouble alarm call, 11 mutual automatic aids and 1 motor vehicle accident:

Trustee Walik informed us that there was a get together to coordinate the Earth Day clean up event on April 9, from 9:00 to 12:00 or longer. The goal is to clean up the park on 41st and Ridgeland. He mentioned raking, trimming trees and cleaning. He asked for volunteers including organizations. He asked that people contact Beth Lukas or himself. There was a reminder of the April 29th Arbor Day celebration. There is another tree application for those who would like to receive a free tree for their parkway. The lottery will be at the April 6th board meeting. Tree trimming is going on. A few hazardous trees have been taken down. Two were located on Oak Park and one on Harlem.

Trustee Zeedyk thanked Police Chief Kretch and Deputy Chief Figueroa for the detailed police reports we now receive. It was neverbroken down like this in the past administration. The activity is even broken down by the officer. He stated, "It is a great job that you are doing."
