The Board of Trustees of the Village of Stickney met in regular session on Tuesday, April 16, 2013 at 7:00 p.m. in the Stickney Village Hall, 6533 W. Pershing Road, Stickney, Illinois.

Immediately after the pledge of allegiance we held a moment of silence for the recent death of long-time auxiliary officer, Robert Goodwin and for the folks in Boston.

**Upon the roll call, the following Trustees were present:

Trustee Horne moved, duly seconded by Trustee Walik, to approve the minutes of the previous regular meeting on Tuesday, April 2, 2013.

CLERK'S REPORT: The clerk announced that the Illinois Department of Transportation kicked off their "Gear Up-Ride-Smart" motorcycle safety campaign. The campaign promotes safe motorcycle riding through continued training and use of proper gear and reminds all motorcyclists to get licensed, get proper training, and keep motorcycle equipment well maintained. "Gear Up-Ride Smart" also warns against riding after drinking.

The clerk provided information on the possibility of the Midway Airport control tower being closed down in the middle of the night. She has been in communication with Congressman Lipinski's office and he is strongly fighting it. We have to have faith in him that he can stop this. It is a very busy airport.

TRUSTEES REPORTS: Trustee Morelli provided the Stickney Fire Department Report for the month of March, 2013. Calls: There were 93 calls as follows: 55 ambulance calls, 5 service calls, 11 mutual automatic aid to other town calls, 17 automatic trouble fire alarms, 4 vehicle accidents, 1 working fire caused by rubbish.. In the year 2013 the fire department 257 calls.

Trustee Walik reminded us that Arbor Day will be recognized on April 30, 2013 at both of our school where they will plant a tree. We lost 30 trees so far to Emerald Ash. We would like to replace 15 of them. Due to the weather, they can't get the trucks in to pull the trees out. It will be a slow process. If someone wants a free tree planted by the village in the parkway let us know.

There being no further business, Trustee Walik moved, duly seconded by Trustee Savopoulos that the meeting be adjourned. Upon which the Board adopted the motion at 7:06 p.m.

Each year prior to Memorial Day, millions of Americans wear little poppies in memory of the many men and women who died in the wars and conflicts of our country.

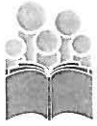

Event Overview

The Library requests the closing of the alley between Grove and Oak Park Avenue and 43rd Street from Oak Park Avenue to Grove. We respectfully request this area to be closed from 7:00 am (for set up) until approximately 2:30 for tear down. The event will begin with the Jesse White Tumblers at 10 am, and they will set up directly on 43rd street and perform in the area between the Library and St Pius X. All other activities will take place outside, on the Library property. We will not require the use of the tot lot.
