Mayor Walik declared the motion carried.

TRUSTEE REPORTS:

Trustee Savopoulos: He reminded us about the 50/50 Sidewalk program. We now replace the registered sidewalks in July. Last year there were few applications filed. Applications can be filed at the front office. He suggested that people also review the damaged sidewalks located near them.

Trustee Milenkovic: He thanked everyone that donated to our Operation Support Our Troops program. The items have been collected in our front foyer. We deliver them to a warehouse and they get packaged up and donated to troops around the world. The Mayor started this effort many years ago and we decided to continue it. Trustee Torres will call the warehouse in a day or two. They close around Christmas time. We will continue taking donations until we deliver what we have. He also enlightened people

to our Visitors Center located at the back of the room. The Hawthorn Racetrack donated box-seat tabs. In the old days they would have these medal tabs that you would place on your pocket or sleeve to identify your box seat. There are a lot of neat things in there.

Trustee Torres: The Trustee reminded people of the senior Christmas party on Saturday from 11:00 to 1:00 and the kids Christmas party is 2:00 to 4:00. It is for Stickney residents only. It will be at the Stickney North Clinic on 40th and Euclid. Come and enjoy a day with us.

Trustee Hrejsa: He thanked the staff and the volunteers who come out and help us with the luncheon and the Christmas Parties. We do have pet pictures with Santa on December 16 from 1:00 to 3:00 at 41st and Ridgeland.

DEPARTMENT REPORTS:

Public Works Director Joe Lopez: The leaf program is over for the year. We did a little more this week. If it is nice out next week we might drive around to see if anyone else has put their leaves out. Waste Management officially stopped picking up lawn and leaf waste. The new streets are done. They are trying to complete the striping. Veterans Day had a sizable number of people in attendance. Chicken was served for lunch. There is quite a bit going on in this little Village. Public Works have been decorating throughout the Village. We are waiting for additional decorations. The Mayor thanked his men for decorating.

Fire Chief Jeff Boyajian: With the holidays here, he warned people to use precautions with extension cords or power strips. Many fires are caused by overloading circuits. Space heaters should only be plugged into the wall. Do not plug into an extension cord. They will overheat and cause a fire. Locate space heaters away from anything that catches fire. Keep candles at least one foot away from everything.

Police Chief Jim Sasseti: He provided our Monthly Volume Report for the Stickney Police Department for the month of October was 2315 calls, which is an average of seventy-five calls per day. We are steadily seeing an increase in our call volume. He wanted to bring it to the Board's attention.

In addition, he asked Officer Maday and K-9 Officer Ali to step forward. They participated in a three-day seminar with Real-Dog Training. It was of no cost to the Stickney Police Department thanks to the sponsorship from Charged-Up K-9 based out of Newark, Illinois. Real-Dog Training is based out of California. K-9 Ali and Officer Maday took the opportunity to participate in real-life situations and scenarios. All the scenarios were based on situations that actually happened in history. At the end of the seminar, there were two awards that were given out to participants. There were fifteen dogs that participated in the training. The judges were five of the participants in the seminar. K-9 Ali received both awards. One was "Best Dog" of the seminar for his performance throughout the weekend. The other was for "Realist Dog Competition" for his understanding and adaptation to scenario-based training. K-9 Ali was presented with the "Best Dog" award. Officer Maday puts in hours of training with Ali. K-9 Ali's success would not have happened if it were not for Officer Maday's dedication. They are both valued members of our department. We are proud of both of you.

The Mayor acknowledged Officer Maday and mentioned that Becky puts in a lot of work every day. They are seen on Ridgeland and the dog park working. They work with other municipalities. He congratulated Officer Maday.

There being no further business, Trustee Milenkovic moved, duly seconded by Trustee Hrejsa that the meeting be adjourned. Upon which the Board adopted the motion at 7:21 p.m.

ORDINANCE NO. 2023-20

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS

WHEREAS, the Village of Stickney (the "Village") is a home rule municipal corporation in accordance with Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970; and

WHEREAS, the Village has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs, and to review, interpret and amend its ordinances, rules and regulations; and

WHEREAS, the Village President (the "President") and the Board of Trustees of the Village (the "Village Board" and with the President, the "Corporate Authorities") have determined and do hereby determine that the amounts of money specified herein, exclusive of any cost of conducting an election required by the general election law, are estimated to be necessary to be raised by taxation upon the taxable property in the Village; and

WHEREAS, in connection therewith, the Corporate Authorities previously adopted the annual appropriation ordinance for the fiscal year beginning May 1, 2023, and ending April 30, 2024; and

WHEREAS, the Corporate Authorities have determined that it is advisable, necessary, and in the best interests of the Village to levy and assess taxes for the fiscal year beginning May 1, 2023, and ending April 30, 2024; and

WHEREAS, in connection with the adoption of its tax levy, the Village has complied with Sections 18-60 through 18-85 of the Truth in Taxation Law (35 ILCS 200/18-60 through 35 ILCS 200/18-85), the Open Meetings Act (5 ILCS 120/1, *et seq.*) and all other applicable state and local laws;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, as follows:

**ARTICLE I.
IN GENERAL**

SECTION 1. INCORPORATION CLAUSE.

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preambles to this Ordinance are full, true and correct and do hereby, by reference, incorporate and make them part of this Ordinance as legislative findings.

SECTION 2. PURPOSE.

The purpose of this Ordinance is to approve the levy and assessment of taxes for the Village for the fiscal year beginning May 1, 2023 and ending April 30, 2024 and to authorize the President or his designee to take all steps necessary to effectuate the intent of this Ordinance.

**ARTICLE II.
AUTHORIZATION**

SECTION 3. AUTHORITY

This Ordinance is enacted pursuant to the provisions of the Illinois Municipal Code, the Illinois Property Tax Code and the Village's home rule powers as set forth in the Constitution of the State of Illinois.

SECTION 4. OTHER ACTIONS AUTHORIZED

The officers, employees and/or agents of the Village shall take all action necessary or reasonably required to carry out, give effect to and consummate the legislative action contemplated by this Ordinance and shall take all action necessary in conformity therewith. The officers, employees and/or agents of the Village are specifically authorized and directed to draft and disseminate any and all necessary forms to be utilized in connection with this Ordinance.

**ARTICLE III.
TAX LEVY**

SECTION 5. TOTAL AMOUNT OF APPROPRIATIONS TO BE COLLECTED FROM THE TAX LEVY.

The total amount of appropriations for all corporate purposes legally made to be collected from the tax levy of the current fiscal year is hereby ascertained to be the sum of \$2,826,142.00.

SECTION 6. PURPOSES PROVIDED FOR.

The sum of \$2,826,142.00 being the total of appropriations heretofore legally made that are to be collected from the tax levy of the current fiscal year of the Village for all corporate purposes of the Village, for purposes of providing for a Policemen's Pension Fund and such other corporate purposes as permitted by statute as set forth on Exhibit A, attached hereto and incorporated herein, as appropriated for the current fiscal year by the annual appropriation ordinance of the Village for the current fiscal year, be and the same is hereby levied upon all of the taxable property in the Village subject to taxation for the current year, the specific amounts as levied for the various funds heretofore named being included herein on Exhibit A by being placed in separate columns under the heading "Amount To Be Raised By Tax Levy," which appears over the same, the tax so levied being for the current fiscal year of the Village, and for said appropriation to be collected from said tax levy, the total of which has been ascertained as aforesaid and being as provided in Exhibit A, as if fully set forth herein.

SECTION 7. AMOUNT LEVIED

The total amount of \$2,826,142.00 ascertained above, be and is hereby levied and assessed on all property subject to taxation within the Village according to the value of said property as assessed and equalized for state and county purposes for the current year.

SECTION 8. STATE AUTHORITY TO ADOPT ORDINANCE.

This levy Ordinance is adopted pursuant to the procedures set forth in the Illinois Municipal Code and the Illinois Property Tax Code, provided, however, any tax rate limitation or any other substantive limitations as to tax levies set forth in applicable law that are in conflict with this Ordinance shall not be applicable to this Ordinance pursuant to Article VII, Section 6 of the Constitution of the State of Illinois.

SECTION 9. CERTIFICATION OF LEVY.

There is hereby certified to the Cook County Clerk of Cook County, Illinois, the total amount \$2,826,142.00 which total amount the Village requires to be raised by taxation for the current fiscal year of the Village, and the Village Clerk is hereby authorized and directed to file with the Cook County Clerk, on or before the time required by law, which is the last Tuesday in December, a certified copy of this Ordinance.

**ARTICLE III.
HEADINGS, SAVING CLAUSES,
PUBLICATION, EFFECTIVE DATE**

SECTION 10. HEADINGS.

The headings of the articles, sections, paragraphs and subparagraphs of this Ordinance are inserted solely for the convenience of reference and form no substantive part of this Ordinance nor should they be used in any interpretation or construction of any substantive provision of this Ordinance.

SECTION 11. SEVERABILITY.

The provisions of this Ordinance are hereby declared to be severable and should any provision of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable and as though not provided for herein and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

SECTION 12. SUPERSEDER.

All code provisions, ordinances, resolutions, rules and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

SECTION 13. PUBLICATION.

A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

SECTION 14. EFFECTIVE DATE.

This Ordinance shall be effective and in full force immediately upon its passage and approval.

RESOLUTION NO. 20-2023

A RESOLUTION FORGIVING CERTAIN INTERFUND DEBT FOR THE VILLAGE OF STICKNEY, COUNTY OF COOK, STATE OF ILLINOIS.

* * * * *

WHEREAS, the Village of Stickney, County of Cook, State of Illinois (the “Village”) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, the Village President (the “President”), the Village Clerk, and the Board of Trustees of the Village (the “Village Board”) constitute the duly elected, qualified and acting officials of the Village; and

WHEREAS, the President and the Village Board (collectively, the “Corporate Authorities”) are committed to the efficient operation of government; and

WHEREAS, it is common practice for municipalities to make interfund loans between a municipality’s different funds; and

WHEREAS, the Village has previously made interfund loans between the Village’s general fund (the “General Fund”) and the Village’s water fund (“Water Fund”); and made interfund loans between the Village’s capital fund (“the Capital Fund”) and the Village’s General Fund; and

WHEREAS, the Village’s General Fund currently has an outstanding debt balance owed to the Water Fund, and the Village’s Capital Fund has an outstanding debt balance due to the General Fund (the “Interfund Debt”); and

WHEREAS, Corporate Authorities have determined that it is necessary and in the best interests of the Village to forgive the Interfund Debt;

NOW, THEREFORE, BE IT RESOLVED by the Village President and the Board of Trustees of the Village of Stickney, County of Cook, State of Illinois, as follows:

**ARTICLE I.
IN GENERAL**

Section 1.0 Incorporation Clause.

All of the recitals hereinbefore stated as contained in the preambles to this Resolution are full, true and correct, and the Village Board does hereby, by reference, incorporate and make them part of this Resolution as legislative findings.

Section 2.0 Purpose.

The purpose of this Resolution is to forgive the Interfund Debt and to further authorize the President or his designee to take all steps necessary in accordance with this Resolution and to ratify any steps taken to effectuate those goals.

Section 3.0 Invocation of Authority.

This Resolution is adopted pursuant to the authority granted to the Village by the Constitution of the State of Illinois and the Illinois Compiled Statutes.

Section 4.0 State Law Adopted.

All applicable provisions of the Illinois Compiled Statutes, including the Illinois Municipal Code, as may be amended from time to time, relating to the purposes of this Resolution are hereby incorporated herein by reference.

**ARTICLE II.
APPROVAL & AUTHORIZATION**

Section 5.0 Authorization.

The Corporate Authorities hereby forgive the Interfund Debt. The Corporate Authorities hereby further authorize and direct the President to execute and ratify the execution of all necessary

documents and perform all necessary acts to effectuate the intent of this Resolution and to authorize and direct the expenditure of all costs related thereto or resulting therefrom.

Section 6.0 Other Actions Authorized.

The officers, employees and/or agents of the Village shall take all action necessary or reasonably required to carry out and give effect to the intent of this Resolution and shall take all actions necessary in conformity therewith.

**ARTICLE III.
HEADINGS, SAVINGS CLAUSES,
PUBLICATION, EFFECTIVE DATE**

Section 7.0 Headings.

The headings for the articles, sections, paragraphs and sub-paragraphs of this Resolution are inserted solely for the convenience of reference and form no substantive part of this Resolution nor should they be used in any interpretation or construction of this Resolution.

Section 8.0 Severability.

The provisions of this Resolution are hereby declared to be severable and should any provision, clause, sentence, paragraph, sub-paragraph, section or part of this Resolution be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision, clause, sentence, paragraph, sub-paragraph, section or part shall be excluded and deemed inoperative, unenforceable and as though not provided for herein, and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect. It is hereby declared to be the legislative intent of the Village Board that this Resolution would have been adopted had not such unconstitutional or invalid provision, clause, sentence, paragraph, sub-paragraph, section or part thereof been included.

Section 9.0 Superseder.

All code provisions, ordinances, resolutions and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

Section 10.0 Publication.

A full, true and complete copy of this Resolution shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

Section 11.0 Effective Date.

This Resolution shall be in full force and effect following its passage, approval and publication, as provided by law.
