ORDINANCE NO. 2014-13

AN ORDINANCE AMENDING CHAPTER 14 "MOTOR VEHICLES AND TRAFFIC" BY AMENDING SECTION 14-161.1 (ELIMINATING RESIDENTIAL PARKING ZONE A)

BE IT ORDAINED by the President and Board of Trustees of the Village of Stickney, Cook County, Illinois as follows:

Section 1. Section 14-161.1 "Residential Parking Zones" of Chapter 14, "Motor Vehicles and Traffic" of the Municipal Code, Village of Stickney, Illinois, is hereby amended to read as follows:

Section 14-161.1. Residential Parking Zones.

- (a) Establishment of zones. There is hereby designated residential parking zones as set forth in subsections (f), (g) and (k) of this section.
- (b) Permit decals required. A resident of the village shall, upon request, be furnished with a decal bearing the words, " Stickney Resident Parking Permit." Such decal shall also have, with its borders, a designation of the parking zone corresponding to the zone in which the requesting person resides. Decals issued hereunder shall be affixed, in accordance with the instructions printed thereon which are made part hereof, immediately above the vehicle license.
- (c) Permits, decals, application. Certain parking spaces shall be designated by signs indicating zone resident parking only. When such official signs are erected, parking shall be restricted to service or delivery vehicles whose operators are doing business with residents of the zone, and to vehicles displaying resident or visitor parking permits. All such spaces shall be designated as tow zones. Resident permits to park in such spaces are available to residents residing on properties adjacent to the applicable zone upon application to the village collector or a form to be provided for this purpose, which application shall include the name, address, telephone number of the applicant and vehicle tag number. Resident parking permits shall be in decal form and in colors designated by the village collector and shall be numbered. Such permits shall be affixed to the windshields of vehicles directly above the current vehicle license where they may be visible from the exterior of the vehicle.
- (d) Visitor parking cards. Residents of the village shall, upon request, be furnished with a maximum of two cards bearing the words "Stickney Visitor Parking Card." Such cards shall be white in color and numbered and have, within the borders thereof, a large capital letter to indicate the residential parking zone in which they may be used. The first two visitor parking cards shall be issued without charge to the resident, but an additional replacement card shall be issued only upon the payment of a \$5.00 fee and only after a sworn affidavit by the resident is filed with the village collector attesting to the loss, destruction or theft of a visitor parking card previously issued. No person shall sell, assign, rent or lease any such visitor parking card or charge a fee for the use thereof. No person shall file a sworn affidavit, as required in this section, which such person knows to be false at the time of filing.

- (e) Exceptions. This section does not apply to the parking of an ambulance, emergency vehicle of any mental agency, repair vehicle of any public utility or village-owned vehicle, when such vehicle is being used in the performance of emergency duties.
- (f) Residential parking zone "W" locations and restricted hours of parking.
 - Effective Friday through Sunday: 7:00 p.m. to 12:00 midnight: The north side of 41st Street from Harlem Avenue to Wisconsin Avenue. The east and west sides of Maple Avenue from 41st Street to 43rd Street.
 - The east and west sides of Wisconsin Avenue from 41st Street to 43rd Street.
- (g) Residential parking zone "E" locations and restricted hours of parking.

Effective Monday through Friday:

9:00 a.m. to 12:p.m.

1:00 p.m. to 4:00 p.m.

Scoville Avenue (east side) from the south line of the first alley south of 41st Street to a point 200 feet south of said south line of such alley. Home Avenue (east side) from the south side of 44th Street to the north side of 45th Street.

- (h) RESERVED
- (i) No parking east side of Ridgeland Avenue. Parking shall be restricted at all times on the east side of Ridgeland Avenue, from the point of the southeast corner of 43rd Street at the Water Reclamation Sanitary District property fence, 100 feet north.
- (j) No parking south side of 43rd Street. Parking shall be restricted at all times on the south side of 43rd Street, from the point of the southwest corner of East Avenue to the southwest corner of Ridgeland Avenue, except that area designated as off-street diagonal parking between the fire station and Ridgeland Avenue, and, the north side of 43rd Street from the point of the northeast corner of Gunderson Avenue to the northwest corner of Elmwood Avenue.
- (k) Residential parking zone "E" areas restricted at all times: North side of 43rd Street from a point of the northeast corner of Elmwood Avenue to the northwest corner of Ridgeland Avenue. West side of Ridgeland Avenue from the point of the southwest corner of Pershing Road to the northwest corner of 43rd Street.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and posting of signs as provided by law.

BE IT ORDAINED by the President and Board of Trustees of the Village of Stickney, Cook County, Illinois, as follows:

Section 1. Adoption. Section 10-82 of Chapter 10, "Coin/Currency Amusement Devices," Article II, Division 3, is hereby amended to read as follows:

Section 10-82. Video Gaming Permitted only on Premises Where Alcoholic Liquor is sold at Retail – Payment of License Fee.

- (a) Any establishment within the village which is licensed to sell alcoholic liquor and has obtained a license to operate a video gaming terminal from the Illinois Gaming Board at such premises shall be required to apply for and obtain a video gaming sticker from the village for each video gaming terminal located at such establishment.

- (c) The license fee for the operator of the premises shall be \$500 per year, payable annually in advance, for each video gaming terminal set up for operation, leased or distributed to the operator of the premises. The license fee for the owner of each video gaming terminal shall be \$500 per year, payable annually in advance, for each video terminal set up for operation.
- (d) All video gaming terminals at premises within the village shall display a village video gaming sticker at all times.
- (e) Village gaming stickers shall not be issued for any video gaming terminal on any premise that is located within 1,000 feet of a horse racing or riverboat gambling facility or is located within 100 feet of a school or place of worship. The restriction does not apply if the church or school is established after the issuance of the liquor license.

- (f) No more than five video gaming terminals may be located on any premises where alcoholic liquor is sold.
- (g) Video gaming terminals must be located in an area that is restricted to persons over 21 years of age. The entrance to such area must be within the view of at least one employee.
- (h) No holder of a license to sell alcoholic liquor may cause or permit any person under the age of 21 years to use or play a video gaming device.
- (i) Video gaming may be played only during the hours of operation for the consumption of alcohol at that establishment.
- (j) Any holder of a liquor license must comply with any provision of the Act and must also follow all rules, regulations and restrictions imposed by the Illinois Gaming Board.
- (k) Annual fees to be paid shall be for a calendar year without proration should the video gaming terminal operate for any portion of any calendar year.
- (I) Any violation of any provision of this section shall be deemed a violation of the provisions of this chapter and subject to enforcement.

AN ORDINANCE AMENDING SECTION 10-82 OF CHAPTER 10, "COIN/CURRENCY AMUSEMENT DEVICES," OF THE MUNICIPAL CODE OF THE VILLAGE OF STICKNEY WITH RESPECT TO VIDEO GAMING

BE IT ORDAINED by the President and Board of Trustees of the Village of Stickney, Cook County, Illinois, as follows:

Section 1. Adoption. Section 10-82 of Chapter 10, "Coin/Currency Amusement Devices," Article II, Division 3, is hereby amended to read as follows:

Section 10-82. Video Gaming Permitted only on Premises Where Alcoholic Liquor is sold at Retail – <u>Payment of License Fee</u>.

- (a) Any establishment within the village which is licensed to sell alcoholic liquor and has obtained a license to operate a video gaming terminal from the Illinois Gaming Board at such premises shall be required to apply for and obtain a video gaming sticker from the village for each video gaming terminal located at such establishment.
- (b) Any person licensed to sell alcoholic liquor may apply to the Liquor Control Commissioner for a village video gaming sticker on an application form provided by the village and shall specify the name and address of the operator of the premises and the name and address of the owner of each video gaming terminal for which a video gaming sticker is being sought.
- (c) <u>The license fee for the operator of the premises shall be \$500 per year, payable</u> Formatted: Underline annually in advance, for each video gaming terminal set up for operation, leased or distributed to the operator of the premises. Section 1. Section 46-33 "Corporal" of Chapter 46 of the Municipal Code, Village of Stickney, Illinois, is hereby amended to read as follows:

Sec. 46-33. - Corporal.

There are created <u>three</u> positions of corporal which are to be appointed by the Chief of Police with the approval of the Village President and Board of Trustees. A corporal shall retain his rank and status while serving as corporal and shall revert to such rank and status when his term of corporal has ended as determined by the Chief of Police, with the advice and consent of the Village President and Board of Trustees. The corporal shall perform such duties and assignments within his division and such other duties and assignments as assigned by the Chief of Police.

Section 2. This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

Resolution to Increase Loss of Bond & Interest Fund

WHEREAS, the Village of Stickney is a home rule municipality in accordance with the Illinois Constitution of 1970.

WHEREAS, pursuant to the Property Tax Appeals Board, significant refunds have been issued to property owners who have appealed tax assessments and obtained a reduction in taxes.

WHEREAS, the Bond & Interest Fund had \$516,261.65 available as of October 31, 2014 and was short \$73,841.48 to pay bond payments of \$590,103.13 due December 1, 2014. A temporary interfund loan was made to meet bond payments due.

WHEREAS, the Bond & Interest Fund has collected 94.37% of the 2013 tax year with collections of \$758,216.68 as of October 31, 2014 of the total tax levy of \$803,467.00

WHEREAS, an increase in loss from 5.00% to 8.00% based on the Bond & Interest Fund 2014 tax levy of \$772,997.00 per filed bond ordinances would potentially generate an additional \$23,189.91 in collections.

NOW THEREFORE BE IT RESOLVED by the Board of Trustees of the Village of Stickney to Increase Loss of Bond & Interest Fund to 8.00% for the 2014 tax year.

MUTUAL AID BOX ALARM SYSTEM FIRST ADDENDUM TO MABAS MASTER AGREEMENT

This First Addendum to the Mutual Aid Box Alarm System ("MABAS") Master Agreement in the State of Illinois, last amended prior to 2000, is meant to incorporate in its entirely the terms included within the Master Agreement except as specifically changed herein. In the event there is a conflict between the terms and conditions of the Master Agreement and this Addendum, this Addendum shall be controlling.

As the cost of lending mutual aid support has increased in recent times, communities have determined it necessary to agree in advance on cost reimbursement issues prior to the occurrence of an actual emergency. Mutual aid agreements such as the MABAS Master agreement have served as the foundation for navigating cost issues and engaging in these agreements prior to the emergency avoid post-emergency concerns on cost reimbursement.

SECTION FIVE - Compensation for Aid is amended to read as follows:

Equipment, personnel, and/or services provided to this Agreement shall be at no charge to the party requesting aid <u>for the first eight (8)</u> <u>consecutive hours of aid provided to the Stricken Unit;</u> however, any expenses recoverable from third parties shall be equitably distributed among responding parties. <u>Day to day mutual aid should remain free of</u> <u>charge and the administrative requirements of reimbursement make it</u> <u>unfeasible to charge for day-to-day mutual aid.</u> Nothing herein shall operate to bar any recovery of funds from any state or federal agency under any existing statute.

Any Aiding Unit is empowered to and may charge a Stricken Unit for reimbursement for costs of equipment, personnel, and/or services provided under this Agreement for terms of more than eight (8) consecutive hours under the following terms and conditions:

- 1. <u>The amount of charges assessed by an Aiding Unit to a Stricken Unit</u> <u>may not exceed the amount necessary to make the Aiding Unit whole</u> <u>and should only include costs that are non-routine in nature.</u>
- 2. <u>The Aiding Unit must assess no more the "usual and customary"</u> <u>charges for personnel costs pursuant to a collective bargaining</u> <u>agreement, benefit ordinance or compensation policy.</u>
- 3. <u>The fee structure for apparatus and equipment shall be based on</u> <u>FEMA or OSFM rate schedules. If a particular piece of apparatus or</u> <u>equipment is not listed within the FEMA / OSFM rate schedules, a</u> <u>market rate for reimbursement shall be established.</u>

- 4. In no event shall the amount assessed by an Aiding Unit to a Stricken Unit exceed the amount of fees permitted to be assessed under Illinois law.
- 5. <u>Aiding Units must invoice the Stricken Unit within thirty (30) days after</u> the completion of the emergency; once thirty (30) days pass, the aid shall be considered to be a donation of service.
- 6. <u>Mutual Aid and assessing costs for mutual aid cannot in any way be</u> <u>conditioned upon any declaration of a federal disaster.</u>

<u>Member Units are encouraged to consider the adoption of internal policies</u> <u>establishing procedures for cost reimbursement on MABAS mobilizations pursuant to</u> <u>established MABAS procedures for collection and submission of funds.</u>
