<u>Trustee Milenkovic</u>: reminded everyone that the Memorial Day Ceremony is on May 30, 2020, at 11:00am with a light lunch following the ceremony under the pavilion.

<u>Trustee Torres</u>: Cinco de Mayo for as cold as it was, it was such a success. It's nice to see that we have 4 girls softball teams, the most we've ever had. The parade was great and everyone enjoyed all the fun trinkets that were handed out.

DEPARTMENT REPORTS:

<u>Fire Chief Jeff Boyajian</u>: After a long wait we finally received it the ambulance that was ordered in July of last year We have it parked out front if anyone would like to see it. Thank you to the board for their support in purchasing the new ambulance. After sixteen years, it was well overdue.

<u>Police Chief James Sassetti</u>: In the beginning of May our dispatch was taken over by the town of Cicero, and is now a municipal entity, therefore under the new leadership we will start seeing some analytic reports that relates to calls. Partial report showing 1420 calls in April with 47 calls per day. We will see more detailed reports as we move forward being more technology driven. This is the start of good things happening.

Public Comment: Resident had a complaint on the neighbors behind them not picking up after their dogs, they saw a rat in their yard. They presented pictures of houses, 2 on Wisconsin and 3 on Wenonah. One of the houses is putting stuff between neighbor's house and the garage, he doesn't think they should be blocking it. Mayor asked resident to give the pictures to Police Chief Sassetti to handle. They said they also filed a complaint in the front office.

Resident concerned about the dogs on Wesley that are kept in the garage The owner came to court 2 times and was taken out in cuffs because he was unruly. He gets ticketed and the case keeps getting continued and yet they are still keeping them in the garage. This past week when the temperature went up, it registered 126 degrees in the garage.

Police Chief explained that Animal control has the authority to take this case to Bridgeview, Stickney Police Department will help in any way they can. Animal Control can call Cook County Sheriff to seek assistance in handling this. Chief Sassetti suggested that they continue the conversation after the board meeting.

ORDINANCE NO. 08-2022

AN ORDINANCE AUTHORIZING AND APPROVING THE PURCHASE OF IN-CAR SECURITY CAMERAS FOR THE VILLAGE OF STICKNEY, COUNTY OF COOK, STATE OF ILLINOIS

WHEREAS, the Village of Stickney (the "Village") is a home rule municipal corporation in accordance with Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970; and

WHEREAS, the Village has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs, and to review, interpret and amend its ordinances, rules and regulations; and

WHEREAS, the Village's Police Department (the "Department") serves the public by responding to emergencies, protecting residents and visitors, and deterring crime within the Village; and

WHEREAS, to ensure the continued efficient operation of the Department, the Department has determined that it is in need of in-car security cameras for certain vehicles operated by the Department (the "Equipment"); and

WHEREAS, Axon Enterprise, Inc. has provided the Village with a proposal for the purchase and installation of the Equipment (the "Proposal"), incorporated herein and attached hereto as Exhibit A; and

WHEREAS, the Village President (the "President") and the Board of Trustees of the Village (the "Board" and with the President, the "Corporate Authorities") deem it advisable and necessary for the operation of the Department and the health, safety and welfare of the residents of the Village to purchase the Equipment; and

WHEREAS, the Corporate Authorities have determined that it is necessary, advisable, and in the best interests of the Village and its residents to take all steps necessary to purchase the Equipment in accordance with the terms of the Proposal;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, as follows:

SECTION 1: RECITALS. The facts and statements contained in the preamble to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

SECTION 2: PURPOSE. The purpose of this Ordinance is to authorize the purchase of the Equipment in accordance with the terms of the Proposal, and to authorize the President or his designee to take all necessary steps to effectuate the intent of this Ordinance.

SECTION 3: AUTHORIZATION. The Board hereby authorizes the purchase of the Equipment in accordance with the terms of the Proposal; authorizes and directs the President or his designee to execute any and all necessary documentation to effectuate the same, with such insertions, omissions and changes as shall be approved by the President and the Village Attorney; and ratifies any additional actions taken to effectuate the intent of this Ordinance. The Board further authorizes the President or his designee to execute any and all additional documentation that may be necessary to carry out the intent of this Ordinance. The Village Clerk is hereby authorized and directed to attest to and countersign any documentation as may be necessary to carry out and effectuate the purpose of this Ordinance. The Village Clerk is also authorized and directed to affix the Seal of the Village to such documentation as is deemed necessary. To the extent that any requirement of bidding would be applicable to the Equipment described herein, the same is hereby waived.

SECTION 4. HEADINGS. The headings of the articles, sections, paragraphs and subparagraphs of this Ordinance are inserted solely for the convenience of reference and form no substantive part of this Ordinance nor should they be used in any interpretation or construction of any substantive provision of this Ordinance.

SECTION 5. SEVERABILITY. The provisions of this Ordinance are hereby declared to be severable and should any provision of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable and as though not provided for herein and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

SECTION 6. SUPERSEDER. All code provisions, ordinances, resolutions, rules and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

SECTION 7. PUBLICATION. A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

SECTION 8. EFFECTIVE DATE. This Ordinance shall be effective and in full force immediately upon passage and approval as provided by law.

ORDINANCE NO. 09-2022

AN ORDINANCE AUTHORIZING AND APPROVING THE PURCHASE OF COMPUTER EQUIPMENT FOR THE VILLAGE OF STICKNEY, COUNTY OF COOK, STATE OF ILLINOIS

WHEREAS, the Village of Stickney (the "Village") is a home rule municipal corporation in accordance with Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970; and

WHEREAS, the Village has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs, and to review, interpret and amend its ordinances, rules and regulations; and

WHEREAS, the Village's Police Department (the "Department") serves the public by responding to emergencies, protecting residents and visitors, and deterring crime within the Village; and

WHEREAS, to ensure the continued efficient operation of the Department, the Department has determined that it is in need of certain computer hardware and software upgrades to its current information technology system (collectively, the "Equipment"); and

WHEREAS, Dell Technologies has provided the Village with a proposal for the purchase of the Equipment (the "Proposal"), incorporated herein and attached hereto as Exhibit A; and

WHEREAS, the Village President (the "President") and the Board of Trustees of the Village (the "Board" and with the President, the "Corporate Authorities") deem it advisable and necessary for the operation of the Department and the health, safety and welfare of the residents of the Village to purchase the Equipment; and

WHEREAS, the Corporate Authorities have determined that it is necessary, advisable, and in the best interests of the Village and its residents to take all steps necessary to purchase the Equipment in accordance with the terms of the Proposal;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, as follows:

SECTION 1: RECITALS. The facts and statements contained in the preamble to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

SECTION 2: PURPOSE. The purpose of this Ordinance is to authorize the purchase of the Equipment in accordance with the terms of the Proposal, and to authorize the President or his designee to take all necessary steps to effectuate the intent of this Ordinance.

SECTION 3: AUTHORIZATION. The Board hereby authorizes the purchase of the Equipment in accordance with the terms of the Proposal; authorizes and directs the President or his designee to execute any and all necessary documentation to effectuate the same, with such insertions, omissions and changes as shall be approved by the President and the Village Attorney; and ratifies any additional actions taken to effectuate the intent of this Ordinance. The Board further authorizes the President or his designee to execute any and all additional documentation that may be necessary to carry out the intent of this Ordinance. The Village Clerk is hereby authorized and directed to attest to and countersign any documentation as may be necessary to carry out and effectuate the purpose of this Ordinance. The Village Clerk is also authorized and directed to affix the Seal of the Village to such documentation as is deemed necessary. To the extent that any requirement of bidding would be applicable to the Equipment described herein, the same is hereby waived.

SECTION 4. HEADINGS. The headings of the articles, sections, paragraphs and subparagraphs of this Ordinance are inserted solely for the convenience of reference and form no substantive part of this Ordinance nor should they be used in any interpretation or construction of any substantive provision of this Ordinance.

SECTION 5. SEVERABILITY. The provisions of this Ordinance are hereby declared to be severable and should any provision of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable and as though not provided for herein and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

SECTION 6. SUPERSEDER. All code provisions, ordinances, resolutions, rules and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

SECTION 7. PUBLICATION. A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

SECTION 8. EFFECTIVE DATE. This Ordinance shall be effective and in full force immediately upon passage and approval as provided by law.
