**Trustee Zeedyk moved, duly seconded by Trustee Horne, to approve the minutes of the previous regular session on Tuesday, August 21, 2012.**

**Upon the roll call, the following Trustees voted:**

**President O'Reilly declared the motion carried.**

**Trustee Walik moved, duly seconded by Trustee White that the bills, approved by the various committees of the Board, be approved for payment, and to approve warrants which authorize the Village Treasurer to draw checks to pay the bills, to be signed by the authorized signers, as provided for by the Ordinances of the Village of Stickney.**

**CLERK'S REPORT: Information was provided about a Property Tax Outreach event being held at the Stickney Township North Clinic on October 1, 2012 at 10:00 a.m. Taxpayers have an option to submit an appeal form and allowing the Board of Review to research comparable properties or the taxpayer can do their own research. A flyer is in the lobby for people to take. Additional information was provided concerning a Stickney Fire Department Child Safety Seat Check on September 22, from 10:00 a.m. to 4:00 p.m. at the fire house. A flyer is available in the lobby.**

**TRUSTEES REPORTS:**

**Trustee Savopoulos thanked the Mayor for putting Family Day together, the Trustees and all the volunteers. There were a lot of people out there working. He thanked them all.**

Trustee Walik thanked the mayor and each and every one of the volunteers. He included his gratitude to the department heads; the Police Chief Joe Kretch and his staff, the Fire Chief Larry Meyer and his staff, and Public Works Supervisor and his staff for the outstanding job. The weather cooperated and we all had a good time.

Trustee Walik addressed the NO SOLICITATION signs that we have available. He also spoke of the no solicitation list that the village keeps. It was explained that the list using only the addresses is given to solicitors who are requesting a permit. An audience member remarked that one of the energy companies came to her door and saw the No Solicitation sign and claimed not to be conducting solicitation. The woman was advised to call the police. Trustee Walik offered information on the Troops Collection with an October collection due date.

#### DEPARTMENT REPORTS:

Police Chief Joe Kretch asked us to stay alert over school buses. . . . especially when they have their arm out. Some people still don't get the law that you can't pass them. Also, he reminded us about cell phones in school zones. He already stopped someone for talking on their cell phone in a school zone. It is against the law for safety reasons.

Public Works Supervisor Cody Mares recently was approached by a solicitor. The solicitor claimed that he was registered with the village. Supervisor Mares suggested that people not tell them that they will call the police. Instead the people should wait until the solicitor goes to the neighbor's house and then the police can catch the solicitor in action. He also commented on how great the fireworks were at family day.

There being no further business, Trustee Zeedyk moved, duly seconded by Trustee Walik that the meeting be adjourned. Upon which the Board adopted the motion at 7:12 p.m.


