RESOLUTION 09-2010

RESOLUTION OF THE VILLAGE OF STICKNEY, ILLINOIS TO PARTICIPATE IN THE ILLINOIS TELECOMMUNICATOR EMERGENCY RESPONSE TASK FORCE

WHEREAS, the Village of Stickney (the "Village") is a home rule municipality in accordance with the Illinois Constitution of 1970;

WHEREAS, the Village of Stickney seeks to maintain the safety, health, and well-being of its residents; and

WHEREAS, Article VII, Section 10 of the 1970 Illinois Constitution authorizes the Village of Stickney to contract or otherwise associate with other units of local government or with other parties in any manner not prohibited by law or ordinance; and

WHEREAS, the Intergovernmental Cooperation Act (5 ILCS 220/01 *et seq.*) provides that any power or powers, privileges or authority exercised or which may be exercised by an Agency of local government may be exercised jointly with any other Agency of local government whether within or outside of the State of Illinois; and

WHEREAS, the Village of Stickney has determined that it is in their best interest to enter into the Intergovernmental Agreement Relative to natural or man-made occurrences that may result in emergencies that exceed the resources, equipment and/or telecommunications personnel; and

WHEREAS; it is in the best interest of the Village of Stickney to provide for communication procedures, operation procedures, training and the necessary functions to further protection of life and property during emergency or disaster situations; and

NOW THEREFORE, be it resolved by the Board of Trustees of the Village of Stickney, Illinois that the Village shall be bound by the terms and conditions of the Agreement (a copy of which is attached) and the President of the Village shall, in his official capacity, execute a signature page of the Agreement and send the same, along with a certified copy of this Resolution to THE ILLINOIS TELECOMMUNICATOR EMERGENCY RESPONSE TASK FORCE thereby officially including the Village as a member municipality in the Agreement.

The above and foregoing RESOLUTION is unanimously adopted and hereby approved this <u>3rd</u> day of <u>November</u>, 2010 upon a roll call vote of the Board of Trustees of the Village of Stickney, Cook County, Illinois.
