A Proclamation recognizing September 2022 as National Suicide Prevention and Action Month was read. The Mayor proclaimed our full support to the cause.

CLERK'S REPORT: A thank you note was read. Every resident living on the 3900 block between Grove and Clinton signed the card. They were most appreciative for the help they received from the Village to repair the alley entrance to relieve years of flooding at that point.

TRUSTEE REPORTS:

All the trustees congratulated and welcomed our newly appointed Deputy Police Chief, Jerry Chlada Jr. to the Village of Stickney.

Trustee Hrejsa: He thanked all the people who participated in making Family Day run so smoothly. We were reminded that that the Pet Fest is Saturday, September 17, from 1:00 to 3:00 at the pavilion located at 41<sup>st</sup> and Ridgeland. We were reminded that this Sunday is the 21<sup>st</sup> anniversary of 9-1-1. He gave information concerning the events planned at the Berwyn Police Department Memorial event.

Trustee Kapolnek: An invitation was extended for people to participate in Bingo at Saint Pius X Church starting September 17. He also said that Family Day was great.

Trustee Torres: She thanked the Mayor for all the wonderful things he did for Family Day. She was appreciative of all the people who helped to make Family Day successful.

Trustee Milenkovic: He mentioned our visitors center. He displayed a couple of items people recently donated to it. An invitation was extended to people to stop to check the room out. The Trustee announced that our Gas n Wash business located at 39<sup>th</sup> and Cicero Avenue is now open for business. Dunkin Donuts are baked on the premises.

Trustee White: He welcomed the high school civics class in attendance. He invited them to approach the Trustees after the meeting to have their assignment paperwork signed.

DEPARTMENT REPORTS:

Public Works Director Ioe Lopez: The Mayor showed appreciation to Public Works for how organized and prepared they were for Family Day.

Fire Chief Jeff Bovajian: He congratulated Jerry Chlada for his appointment to Deputy Chief. He has known him for years.

Police Chief James Sasseti: A Family Day update was given. There was only one minor incident. Other than that, it went on without a hitch. The Chief provided information on our new Deputy Chief. He served 26 years with the Cicero Police Department advancing through the ranks and commanded numerous units within their organization. **ORDINANCE NO. 2022-16**

**AN ORDINANCE AMENDING CHAPTER 78, SECTION 78-318 AND ADOPTING CHAPTER 78, ARTICLE XII(B) OF THE VILLAGE OF STICKNEY MUNICIPAL CODE REGARDING LOCAL MOTOR FUEL TAX FOR THE VILLAGE OF STICKNEY, COUNTY OF COOK, STATE OF ILLINOIS.**

**WHEREAS**, the Village of Stickney (the "Village") is a home rule municipal corporation in accordance with Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970; and

**WHEREAS**, the Village has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs, and to review, interpret and amend its ordinances, rules and regulations; and

**WHEREAS**, the Village President (the "President") and the Board of Trustees of the Village (the "Village Board" and with the President, the "Corporate Authorities") are committed to ensuring the health, safety and welfare of individuals residing in, working in and visiting the Village; and

**WHEREAS**, pursuant to Public Act No. 101-0032 (the "Public Act"), which among other things creates Section 8-11-2.3 of the Illinois Municipal Code (65 ILCS 5/8-11-2.3), in addition to any other tax that may be imposed, a municipality in a county with a population of over 3,000,000 inhabitants may also impose, by ordinance, a tax on motor fuel at a rate not to exceed \$0.03 per gallon; and

**WHEREAS**, in light of the foregoing, the Corporate Authorities have determined that it is necessary, advisable and in the best interests of the Village and its residents to amend Chapter 78, Section 78-318 and to adopt Chapter 78, Article XII(B) of the Village Code as set forth herein;

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, as follows:**

**ARTICLE I.  
IN GENERAL**

**SECTION 1. INCORPORATION CLAUSE.**

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preambles to this Ordinance are full, true and correct and do hereby, by reference, incorporate and make them part of this Ordinance as legislative findings.

**SECTION 2. PURPOSE.**

The purpose of this Ordinance is to amend Chapter 78, Section 78-318 and to adopt Chapter 78, Article XII(B) of the Village Code to update, amend, and clarify the Village's existing regulations, and to authorize the President or his designee to take all actions necessary to carry out the intent of this Ordinance.

**ARTICLE II.**  
**AMENDMENT OF CHAPTER 78, SECTION 78-318 AND ADOPTION OF CHAPTER 78,  
ARTICLE XII(B) OF THE MUNICIPAL CODE, VILLAGE OF STICKNEY, ILLINOIS**

**SECTION 3.0 AMENDMENT OF CHAPTER 78, SECTION 78-318**

That the Village Code is hereby amended, notwithstanding any provision, ordinance, resolution or Village Code section to the contrary, by amending Chapter 78, Section 78-318 by striking out any language to be removed or repealed and underlining any new language as follows:

**Sec. 78-318. - Imposition of tax on purchase of motor fuel at retail.**

(a) There is hereby imposed and shall be collected a tax upon the privilege of purchasing motor fuel at retail in the village at a rate of \$0.04 per U.S. gallon.

(b) In the event motor fuel is dispensed by a unit of measure other than U.S. gallon, then the tax shall be imposed at the same ratio of \$0.04 per U.S. gallon to the unit of measure.

(c) In addition to any other tax imposed under this section, beginning on July 1, 2019, an additional tax is nov. imposed pursuant to 65 ILCS 5/8 11 2.3, upon all persons in the village engaged in the business of selling motor fuel as now or hereafter defined in the motor fuel tax law at retail for the operation of motor vehicles upon public highways or for recreational watercrafts upon waterways at a rate of \$0.03 per gallon, or the maximum rate permitted by law, of motor fuel sold at retail within the village for the use or consumption and not for resale. This tax shall be collected and discharged in accordance with 65 ILCS 518 11 2.3.

**SECTION 3.1 ADOPTION OF CHAPTER 78, ARTICLE XII(B)**

That the Village Code is hereby amended, notwithstanding any provision, ordinance, resolution or Village Code section to the contrary, by adopting Chapter 78, Article XII(B) as follows:

**Article XII(B) - Imposition of tax on sale of motor fuel at retail.**

**Sec. 78-328. - Tax Imposed**

(a) Beginning on January 1, 2023, an additional tax is imposed pursuant to 65 ILCS 5/8-11-2.3, upon all persons in the village engaged in the business of selling motor fuel as now or hereafter defined in the Motor Fuel Tax Law at retail for the operation of motor vehicles upon public highways or for recreational watercraft upon waterways at a rate of \$0.03 per gallon of motor fuel sold at retail within the village for use or consumption and not for resale. This tax shall be collected and discharged in accordance with 65 ILCS 5/8-11-2.3.

- (b) The tax hereby imposed. and all civil penalties that may be assessed as an incident thereto. shall be collected and enforced by the Department of Revenue of the State of Illinois. The Department of Revenue shall have full power to administer and enforce the provisions of this Section 78-328.

### **SECTION 3.2 OTHER ACTIONS AUTHORIZED.**

The officers, employees and/or agents of the Village shall take all action necessary or reasonably required to carry out, give effect to and consummate the amendments contemplated by this Ordinance and shall take all action necessary in conformity therewith. The officers, employees and/or agents of the Village are specifically authorized and directed to draft and disseminate any and all necessary forms or notices to be utilized in connection with the intent of this Ordinance. The Village Clerk or her designee are hereby authorized and directed to file a copy of this Ordinance with the Department of Revenue for the State of Illinois on or before October 1, 2022.

## **ARTICLE III. HEADINGS, SAVINGS CLAUSES, PUBLICATION, EFFECTIVE DATE**

### **SECTION 4. HEADINGS.**

The headings of the articles, sections, paragraphs and subparagraphs of this Ordinance are inserted solely for the convenience of reference and form no substantive part of this Ordinance nor should they be used in any interpretation or construction of any substantive provision of this Ordinance.

### **SECTION 5. SEVERABILITY.**

The provisions of this Ordinance are hereby declared to be severable and should any provision of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable and as though not provided for herein and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

### **SECTION 6. SUPERSEDER.**

All code provisions, ordinances, resolutions, rules and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

### **SECTION 7. PUBLICATION.**

A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

### **SECTION 8. EFFECTIVE DATE.**

This Ordinance shall be in full force and effect ten (10) days following its passage, approval and publication, as provided by law.
