The Board of Trustees of the Village of Stickney met in regular session on Tuesday, September 5, 2023, at 7:06 p.m. in the Board Room, 6533 W. Pershing Road, Stickney, Illinois.

Upon the roll call, the following Trustees were present: Trustees White, Savopoulos, Milenkovic, Torres, Kapolnek and Hrejsa

Trustee Milenkovic moved, duly seconded by Trustee Kapolnek to approve the minutes of the regular board meeting held on Tuesday, August 15, 2023.

Mayor Walik declared the motion carried.

Trustee White moved, duly seconded by Trustee Savopoulos that the bills, approved by the various committees of the Board, be approved for payment, and to approve warrants which authorize the Village Treasurer to draw checks to pay the bills, to be signed by the authorized signers, as provided for by the Ordinances of the Village of Stickney.

MAYOR'S REPORT: The Mayor thanked everyone for attending our Family Day whether volunteering or coming out. I hope you enjoyed it. It was a little hot out. He thought we had the best bands and the biggest crowds. He thought the fireworks were just OK. He thanked all the department heads and the trustees.

TRUSTEE REPORTS:

<u>Trustee White</u>: He told the students in the audience to come up after the meeting to have their assignments signed.

<u>Trustee Savopoulos</u>: The Trustee wanted to recognize Koppers Chemicals for sponsoring the fireworks. The Mayor thanked other sponsors of Stickney Family Day. McDonalds donated hamburgers for all the volunteers. Pepsi donated all the water. Everyone got free water.

Trustee Torres: We just finished our biggest event of the year. It was spectacular. On Saturday, September 16 is the Pet Fest on 41st and Ridgeland. You can bring your own pet. There will be pet adoptions. There will be crafters and freebees. It is from 1:00 p.m. to 3:00 p.m.

<u>Trustee Kapolnek</u>: Saint Pius X Church bingo starts this Saturday. There is an open kitchen for food. We have three \$500 games.

<u>Trustee Hrejsa:</u> The Haunted Hayride is coming up on October 21st. We are looking for volunteers.

DEPARTMENT REPORTS:

Public Works Director Joe Lopez: This past week has been busy. On Wednesday we cooked chicken breast sandwiches for the Music in the Park. We cooked hamburgers, cheeseburgers and hot dogs. He thanked all the volunteers who pitched in. He reminded people that garbage pickup will be pushed out one day due to the Labor Day holiday. We will be helping out at the Pet Fest cooking. The Mayor stated that Joe was at the grill from sunup to sundown cooking over 500 hamburgers himself. Police Chief lames Sassetti: He reported that were no incidents on Family Day. Concerning the residents that were impacted by the flooding of the summer, FEMA is in our area doing surveys and taking applications for flood damage reimbursements. If you submitted a preliminary flood damage assessment, you should be receiving a call or site visit from FEMA. If you did not submit a preliminary flood damage assessment, FEMA has set up two disaster recovery centers. One of them is at Morton College and it is open from 7:00 a.m. to 7:00 p.m., Monday through Friday. The other location is at the Berwyn public parking garage building in the 3000 block of Grove in Berwyn. You can fill out applications through FEMA in an attempt to recoup some of the funds for damage to your residence over the summer. You can go to the website for more information. The Village is out of the process. FEMA is now handling things. Fire Chief leff Boyajian: The fire department did not see any injuries or bee stings on Family Day. The Mayor thanked all the men and women in his department for coming out at Family Day. They received the DCEO Grant of \$48,000 for 13 sets of turnout gear.

ORDINANCE NO. 2023-<u>18</u>

AN ORDINANCE AMENDING CHAPTER 14, SECTIONS 14-154 AND 14-157 OF THE MUNICIPAL CODE, VILLAGE OF STICKNEY, ILLINOIS REGARDING PARKING ON 41ST STREET.

- WHEREAS, the Village of Stickney (the "Village") is a home rule municipal corporation in accordance with Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970; and
- WHEREAS, the Village has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs, and to review, interpret and amend its ordinances, rules and regulations; and
- WHEREAS, the Village President (the "President") and the Board of Trustees of the Village (the "Village Board" and with the President, the "Corporate Authorities") are committed to ensuring the health, safety and welfare of Village residents; and
- **WHEREAS,** it is essential that emergency vehicles have appropriate clearance traveling on 41st Street within the Village; and
- **WHEREAS**, currently, parking is permitted on both sides of 41st Street intermittently within the Village (the "Regulations"); and
- WHEREAS, to allow appropriate access of emergency vehicles to 41st Street, the Corporate Authorities recognize the need to amend the Regulations; and
- WHEREAS, the Corporate Authorities have determined that Chapter 14, Sections 14-154 and 14-157 of the Municipal Code, Village of Stickney (the "Village Code") should be amended regarding parking on 41st Street; and
- **WHEREAS,** traffic enforcement on Village streets is a valid exercise of the police powers held by the Village; and
- WHEREAS, the Corporate Authorities desire to exercise their home rule authority in implementing the Regulations contemplated herein; and
- **WHEREAS,** based upon the foregoing, the Corporate Authorities have determined that it is necessary, advisable and in the best interests of the Village and its residents to amend Chapter 14, Sections 14-154 and 14-157 of the Village Code regarding parking on 41st Street;
- NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, as follows:

ARTICLE I.

SECTION 1. INCORPORATION CLAUSE.

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preambles to this Ordinance are full, true and correct and do hereby, by reference, incorporate and make them part of this Ordinance as legislative findings.

SECTION 2. PURPOSE.

The purpose of this Ordinance is to amend Chapter 14, Sections 14-154 and 14-157 of the Village Code regarding parking on 41st Street as provided for herein and to authorize the President or his designee to take all action necessary to carry out the intent of this Ordinance, including the installation of necessary street signs.

ARTICLE II.

AMENDMENT OF CHAPTER 14, SECTIONS 14-154 AND 14-157 OF THE MUNICIPAL CODE, VILLAGE OF STICKNEY, ILLINOIS

SECTION 3.0. AMENDMENT OF CHAPTER 14, SECTION 14-154.

That the Village Code is hereby amended, notwithstanding any provision, ordinance, resolution or Village Code section to the contrary, by amending Chapter 14, Section 14-154 as follows:

Sec. 14-154. - Parking or standing totally prohibited.

It shall be unlawful for any person to park a vehicle, or permit it to stand, in any of the following areas:

Cicero Avenue.

East Avenue, west side, from 41st Street to 43rd Street.

40th Street, north side, from Harlem Avenue to Home Avenue.

41st Street, south side, between Oak Park Harlem Avenue and Grove Ridgeland Avenue.

41st Street, south side, from the west line of Wisconsin Avenue to the east line of Harlem Avenue.

42nd Street, north side, from Harlem Avenue east to the Harlem Avenue alley.

43rd Street, north side, from Harlem Avenue east to the Harlem Avenue alley.

44th Street, south side, from Harlem Avenue east to a point 150 feet east of the east curbline of Harlem Avenue.

Oak Park Avenue, east side, between 39th Street and 40th Street.

Oak Park Avenue, east side, from the south line of 40th Street to a point 389.8 feet south of the center line of 40th Street.

Pershing Road (39th Street), south side, between Central Avenue and Elmwood Avenue.

39th Street (Pershing Road) from Central Avenue to Cicero Avenue.

39th Street (Pershing Road), south side, from the west line of the entrance to the municipal parking lot of the village located on 39th Street between Euclid Avenue and Wesley Avenue to a point 25 feet west of said west line.

SECTION 3.1. AMENDMENT OF CHAPTER 14, SECTION 14-157.

That the Village Code is hereby amended, notwithstanding any provision, ordinance, resolution or Village Code section to the contrary, by amending Chapter 14, Section 14-157 as follows:

Sec. 14-157. - Parking totally prohibited.

It shall be unlawful for any person to park a motor vehicle in any of the following locations:

Cicero Avenue, from 1-55 to 35th Street.

41st Street both sides from Harlem Avenue to the west line of the first alley easterly thereof.

41st Street (the south side) from Harlem Avenue to Home Avenue.

Oak Park Avenue east side between 42nd Street and 43rd Street.

Pershing Road (39th Street) from the intersection of Elmwood Avenue and Pershing Road to a point 20 feet west therefrom.

Pershing Road (39th Street) from the intersection of Scoville Avenue and Pershing Road to a point 20 feet west therefrom.

Pershing Road (39th Street) from the intersection of East Avenue and Pershing Road to a point 20 feet west therefrom.

Pershing Road (39th Street) from the intersection of Wesley Avenue and Pershing Road to a point 20 feet west therefrom.

Pershing Road (39th Street) from the intersection of Grove Avenue and Pershing Road to a point 20 feet west therefrom.

SECTION 3.2. OTHER ACTIONS AUTHORIZED.

The officers, employees and/or agents of the Village shall take all action necessary or reasonably required to carry out, give effect to and consummate the amendments contemplated by this Ordinance, and shall take all action necessary in conformity therewith. The officers, employees and/or agents of the Village are specifically authorized and directed to draft and disseminate any and all necessary forms or notices to be utilized in connection with the intent of this Ordinance and to install any necessary signage in accordance with this Ordinance.

ARTICLE III. HEADINGS, SAVINGS CLAUSES, PUBLICATION, EFFECTIVE DATE

SECTION 4. HEADINGS.

The headings of the articles, sections, paragraphs and subparagraphs of this Ordinance are inserted solely for the convenience of reference and form no substantive part of this Ordinance nor should they be used in any interpretation or construction of any substantive provision of this Ordinance.

SECTION 5. SEVERABILITY.

The provisions of this Ordinance are hereby declared to be severable and should any provision of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable and as though not provided for herein and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

SECTION 6. SUPERSEDER.

All code provisions, ordinances, resolutions, rules and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

SECTION 7. PUBLICATION.

A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

SECTION 8. EFFECTIVE DATE.

This Ordinance shall be effective ten (10) days after its passage and approval in accordance with Illinois law.
