Prior to the vote the Mayor explained that the application was late because the requester was out-of-town. The proper signatures were included.

MAYOR'S REPORT: The Mayor informed us that a small flyer came out recently. Those who do not get it can see it on the website. He thanked Beth and Mitch for putting it together quickly. It contains save-the-dates. There are articles from the Police Chief, Fire Chief and Public Works Director. There is information on the Cinco De Mayo Fest on May 2, 2021. The front office will stay open during the months of May and June from 8:00 a.m. to 6:00 p.m. to accommodate vehicle sticker sales.

CLERK'S REPORT: The clerk reported that the Cook County Clerk will be certifying the Consolidated Election results on April 27, 2021 at 5:00 p.m. The Official Certificate of Results can be downloaded from their website. The Clerk gave another reminder to the people who still need to complete their Statement of Economic Interest filing.

Trustee Reports:

Trustee Kapolnek: Reminded people that the Village sponsored lawn cutting will start on May 1.

Trustee Torres: Information was provided about the Cinco De Mayo Fest May 2nd at 43rd and Ridgeland. There will be music by DJ Gabe from 3:00 p.m. to 6:00 p.m. and Caliente from 6:00 p.m. to 8:00 p.m. There will be features for the kids. Food and drinks available.

Trustee Milenkovic: The Arbor Day Foundation wrote to congratulate Stickney on earning recognition as a 2020 Tree City USA. Residents of Stickney should be proud to live in a community where planting and caring for trees are a priority. The Trustee thanked the Tree Board for all their hard work and especially the Mayor and Beth Lukas for doing quite a bit of the work involved. He said, "I get quite a bit of the credit as the Chairman of the Tree Board, but they do quite a bit of the work."

Thursday, April 22, is Earth Day and Friday, April 30 is Arbor Day. The Midway Noise Compatibility meeting is next Thursday. Therefore, I will have a report at the next meeting.

Trustee Savopoulos: Announced a new business in the Village. It will be at 39th and Cicero Avenue. They have filed the paperwork to get a zoning variance on that property. The owner is looking to put in a gas station and a car wash. Gas stations are allowed. A car wash is a special use. The Zoning Board is scheduled to meet on May 11 at 6:00 p.m. to consider the applicant's request. The owner will be sending out notices to surrounding businesses and residents this Friday. This is within the timeframe required. Proof will be sent to the Building Inspector that the mailings have gone out. This facility will have a Dunkin Donuts with a drive thru and a Steak n Egger restaurant.

David Gonzalez, Finance Director: An update was provided of the previous ten months of the fiscal year. A couple of screens of information were presented. A focus was given of the General Fund. We did receive \$559,000 from the Cook County Covid-19 reimbursement. It helped us to stay within our budget. We had anticipated a lot more in permit fees from Hawthorne. Those were delayed. The reimbursement helped with police and fire. Expenditures were higher this year because of Covid overtime in certain departments. He anticipated that we would come in balanced as of April 30th. Moving forward we were told of the Village's commitment to the funding the Police Pension Fund and the IMRF. Another graphic was displayed that highlighted the Police Pension Fund over the last few years. It was mentioned that The American Rescue Plan would provide us \$811,000. We have not received it yet. We would get \$405,000 in fiscal year 2022 and in the next year we would get another \$405,000. He recommended that we use it for our normal operations in case the permits or sales taxes do not come in. We should remain conservative. We will create the 2022 fiscal budget with that \$405,000 in the General Fund. If we see that we are trending a little bit better, we could see within six months on how to spend that money. He advised that we run conservative like we have done the last four years. That would also keep the levy flat so we can keep funding the pensions.

The Mayor thanked him for all his help. The graphics were awesome. We were reminded that we have not received one cent of the \$811,000. We never spend any money we do not have.

Public Works Director Joe Lopez: He thanked Trustee Milenkovic for helping the Village get trees for the Village.

Police Chief James Sasseti:

Stickney Police Department 2020 Annual Report

The Chief provided a synopsis of the past year's challenges faced by the Police Department. We overcame situations such as civil unrest and Covid-19 protocols. We did not have any civil unrest in our community.

We have twenty-one full-time officers. The most ever. The auxiliary officer contingency was increased to seventeen officers.

Adjudication was a challenge. Due to Covid-19 orders, hearings were held outdoors at the fire department, over Zoom, and in our normal courtroom with significant less capacity. Overall funds collected in 2020 increased significantly over previous years.

The Police Chief thanked the Mayor, the members of the Board of Trustees and the community.

Most of our traffic enforcement citations were for speeding violations within our residential community and surrounding areas. People not having insurance decreased by 10% from prior years. The presence of the police helps to reducing our traffic violations. We issue parking citations to seek compliance. We issued a little over 2,800 parking citations. It is a 2 ½ % decrease over the prior year.

We have made technology upgrades to the police department to make our police officer's job more efficient, more effective, and easier. We will continue with the initiatives in 2021.

RESOLUTION NO. 04-2021

A RESOLUTION APPOINTING CERTAIN MEMBERS OF THE BOARD OF TRUSTEES AND CERTAIN OFFICERS, EMPLOYEES AND OFFICIALS OF THE VILLAGE OF STICKNEY TO CERTAIN POSITIONS FOR THE VILLAGE OF STICKNEY, COUNTY OF COOK, STATE OF ILLINOIS.

WHEREAS, the Village of Stickney (the "Village") is a home rule municipal corporation in accordance with Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970; and

WHEREAS, the Village has the authority to adopt ordinances and resolutions and to promulgate rules and regulations that pertain to its government and affairs, and to review, interpret and amend its ordinances, resolutions, rules and regulations; and

WHEREAS, the Village President (the "President") and the Board of Trustees of the Village (the "Village Board" and with the President, the "Corporate Authorities") are committed to ensuring the health, safety and welfare of Village residents; and

WHEREAS, the Village President (the "President") and the Board of Trustees of the Village (the "Village Board" and with the President, the "Corporate Authorities") have determined that it is necessary for conducting Village business and for the effective administration of government to appoint certain members of the Village Board ("Trustees") to specified committees; and

WHEREAS, the Corporate Authorities have further determined that it is necessary to appoint certain persons as officers, employees and officials to specific positions, boards, commissions and/or committees within the Village; and

WHEREAS, the Corporate Authorities find that it is in the best interests of the Village to make the specified appointments (the "Appointments"), which are set forth in Exhibit A, attached hereto and incorporated herein;

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, as follows:

**ARTICLE I.
IN GENERAL**

Section 1.0 Findings.

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preambles to this Resolution are full, true and correct and do hereby, by reference, incorporate and make them part of this Resolution as legislative findings.

Section 2.0 Purpose.

The purpose of this Resolution is to authorize the President to appoint the Trustees to the specified committees and to appoint certain persons as officers, employees and officials to specific positions, boards, commissions and/or committees within the Village, as set forth in Exhibit A, and to take all steps necessary to carry out the terms of the Appointments.

Section 3.0 Effectiveness and Term of Appointments.

The Appointments as set forth in Exhibit A are effective immediately and shall expire at 11:59 p.m. on May 4, 2022, or at such other time the President deems necessary, unless otherwise specified in Exhibit A. All prior appointments to the specific positions, boards, commissions and/or committees specified in Exhibit A are hereby removed from their prior appointments upon passage of this Resolution.

**ARTICLE II.
AUTHORIZATION**

Section 4.0 Authorization.

That the Corporate Authorities hereby authorize, approve and, as applicable, consent to the Appointments as set forth in Exhibit A, which is attached hereto and incorporated herein.

**ARTICLE III.
HEADINGS, SAVINGS CLAUSES, PUBLICATION,
EFFECTIVE DATE**

Section 5.0 Headings.

The headings of the articles, sections, paragraphs and subparagraphs of this Resolution are inserted solely for the convenience of reference and form no substantive part of this Resolution nor should they be used in any interpretation or construction of any substantive provision of this Resolution.

Section 6.0 Severability.

The provisions of this Resolution are hereby declared to be severable and should any provision of this Resolution be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable and as though not provided for herein, and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

Section 7.0 Superseder.

All code provisions, ordinances, resolutions, rules and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

Section 8.0 Publication.

A full, true and complete copy of this Resolution shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

Section 9.0 Effective Date.

This Resolution shall be effective and in full force immediately upon passage and approval.
