MAYOR'S REPORT: The mayor welcomed the students to our meeting. He reminded people that this Saturday is Pictures with Your Pets and Santa Claus from 1:00 to 3:00. There will be give-a-ways and treats. He also reminded people that the Senior Christmas Luncheon will be on December 14, 2024, from 11:00 a.m. to 1:00 p.m. at Saint Pius. The kids Christmas party is December 14, 2024, at Saint Pius, from 1:00 to 3:00. Santa will be there to take pictures with each person. There will be pizza, candy, and gifts. He then thanked all the trustees and department heads for their hard work. Everything is going great. We will be having a meeting before the end of the year.

Mayor Walik declared the motion carried.

In addition: The clerk gave some statistics from the November Presidential Election. She thought it would be interesting for the visiting Government Class students. In Stickney Township, there were 6,278 votes for Harris; there were 6,747 votes for Trump; resulting in Trump receiving 51.7% of the votes.

TRUSTEE REPORTS:

Trustee Hrejsa: Suggested people stay warm.

Trustee Torres: She reminded people about the kids Christmas party on December 14th at Saint Pius. They will have Santa, games, pizza, and pictures with Santa.

Trustee Milenkovic: The summary for the Support our Troops was given. We gather items in the front lobby. We then take it to a warehouse and then they will ship it around the world. Some items collected are medicine, food, and toiletries. This year there was 218 pounds. Last year we had 154 pounds.

In addition, he read the report from our tree lottery from Public Works Director Joe Lopez. There were eighteen trees planted from the lottery where residents requested a tree for their front parkway. The Village purchases the trees, and the resident agrees to maintain the tree. Tom Kadolph, of Cedar Path Nurseries, donated three trees. A list of the variety of trees planted was given. The mayor thanked him for his efforts.

Trustee Savopoulos: He remarked that the sidewalks are ready for the snow and ice.

Trustee White: He informed the students that any Board member could sign their assignment sheets.

DEPARTMENT REPORTS:

Public Works Director Joe Lopez: The leaf season is over. Although, they can take care of situations where people still have leaves. He gave a lesson on the catch basins on the streets. This drain collects leaves and debris. Public Works will be cleaning all the catch basins. We will be switching over the trucks to prepare them for the snow. We have enough salt for the winter.

Fire Chief Jeff Boyajian: A slide-show presentation was given showing the progress of the building of the Quint Firetruck. It is in the eighth week of progress. They are projecting that it will be finished by the end of January. The cab has been painted. They body has been fabricated and should be painted this week. Soon it will be placed on the chassis. The wiring is quite tedious. He then thanked the Board for allowing us to purchase this. The old one broke down. It has been a two-and-a-half-year process. It has airbags in it and other safety measures. He plans to go there at the end of the month and take more pictures. The factory is in Appleton, Wisconsin. They build 4100 trucks per year. Currently, the wait process is three-and-a-half years. The cost of our new truck is \$1.4 million. There is a website where you can observe all the trucks in the process of being built.

There being no further business, Trustee White moved, duly seconded by Trustee Savopoulos that the meeting be adjourned. Upon which the Board adopted the motion to adjourn at 7:29 p.m.

ORDINANCE NO. 2024- 17

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS

WHEREAS, the Village of Stickney (the "Village") is a home rule municipal corporation in accordance with Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970; and

WHEREAS, the Village has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs, and to review, interpret and amend its ordinances, rules and regulations; and

WHEREAS, the Village President (the "President") and the Board of Trustees of the Village (the "Village Board" and with the President, the "Corporate Authorities") have determined and do hereby determine that the amounts of money specified herein, exclusive of any cost of conducting an election required by the general election law, are estimated to be necessary to be raised by taxation upon the taxable property in the Village; and

WHEREAS, in connection therewith, the Corporate Authorities previously adopted the annual appropriation ordinance for the fiscal year beginning May 1, 2024, and ending April 30, 2025; and

WHEREAS, the Corporate Authorities have determined that it is advisable, necessary, and in the best interests of the Village to levy and assess taxes for the fiscal year beginning May 1, 2024, and ending April 30, 2025; and

WHEREAS, in connection with the adoption of its tax levy, the Village has complied with Sections 18-60 through 18-85 of the Truth in Taxation Law (35 ILCS 200/18-60 through 35 ILCS 200/18-85), the Open Meetings Act (5 ILCS 120/1, *et seq.*) and all other applicable state and local laws;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, as follows:

**ARTICLE I.
IN GENERAL**

SECTION 1. INCORPORATION CLAUSE.

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preambles to this Ordinance are full, true and correct and do hereby, by reference, incorporate and make them part of this Ordinance as legislative findings.

SECTION 2. PURPOSE.

The purpose of this Ordinance is to approve the levy and assessment of taxes for the Village for the fiscal year beginning May 1, 2024 and ending April 30, 2025 and to authorize the President or his designee to take all steps necessary to effectuate the intent of this Ordinance.

**ARTICLE II.
AUTHORIZATION**

SECTION 3. AUTHORITY

This Ordinance is enacted pursuant to the provisions of the Illinois Municipal Code, the Illinois Property Tax Code and the Village's home rule powers as set forth in the Constitution of the State of Illinois.

SECTION 4. OTHER ACTIONS AUTHORIZED

The officers, employees and/or agents of the Village shall take all action necessary or reasonably required to carry out, give effect to and consummate the legislative action contemplated by this Ordinance and shall take all action necessary in conformity therewith. The officers, employees and/or agents of the Village are specifically authorized and directed to draft and disseminate any and all necessary forms to be utilized in connection with this Ordinance.

**ARTICLE III.
TAX LEVY**

SECTION 5. TOTAL AMOUNT OF APPROPRIATIONS TO BE COLLECTED FROM THE TAX LEVY.

The total amount of appropriations for all corporate purposes legally made to be collected from the tax levy of the current fiscal year is hereby ascertained to be the sum of \$2,953,215.00.

SECTION 6. PURPOSES PROVIDED FOR.

The sum of \$2,953,215.00 being the total of appropriations heretofore legally made that are to be collected from the tax levy of the current fiscal year of the Village for all corporate purposes of the Village, for purposes of providing for a Policemen's Pension Fund and such other corporate purposes as permitted by statute as set forth on Exhibit A, attached hereto and incorporated herein, as appropriated for the current fiscal year by the annual appropriation ordinance of the Village for the current fiscal year, be and the same is hereby levied upon all of the taxable property in the Village subject to taxation for the current year, the specific amounts as levied for the various funds heretofore named being included herein on Exhibit A by being placed in separate columns under the heading "Amount To Be Raised By Tax Levy," which appears over the same, the tax so levied being for the current fiscal year of the Village, and for said appropriation to be collected from said tax levy, the total of which has been ascertained as aforesaid and being as provided in Exhibit A, as if fully set forth herein.

SECTION 7. AMOUNT LEVIED

The total amount of \$2,953,215.00 ascertained above, be and is hereby levied and assessed on all property subject to taxation within the Village according to the value of said property as assessed and equalized for state and county purposes for the current year.

SECTION 8. STATE AUTHORITY TO ADOPT ORDINANCE.

This levy Ordinance is adopted pursuant to the procedures set forth in the Illinois Municipal Code and the Illinois Property Tax Code, provided, however, any tax rate limitation or any other substantive limitations as to tax levies set forth in applicable law that are in conflict with this Ordinance shall not be applicable to this Ordinance pursuant to Article VII, Section 6 of the Constitution of the State of Illinois.

SECTION 9. CERTIFICATION OF LEVY.

There is hereby certified to the Cook County Clerk of Cook County, Illinois, the total amount \$2,953,215.00 which total amount the Village requires to be raised by taxation for the current fiscal year of the Village, and the Village Clerk is hereby authorized and directed to file with the Cook County Clerk, on or before the time required by law, which is the last Tuesday in December, a certified copy of this Ordinance.

**ARTICLE III.
HEADINGS, SAVING CLAUSES,
PUBLICATION, EFFECTIVE DATE**

SECTION 10. HEADINGS.

The headings of the articles, sections, paragraphs and subparagraphs of this Ordinance are inserted solely for the convenience of reference and form no substantive part of this Ordinance nor should they be used in any interpretation or construction of any substantive provision of this Ordinance.

SECTION 11. SEVERABILITY.

The provisions of this Ordinance are hereby declared to be severable and should any provision of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable and as though not provided for herein and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

SECTION 12. SUPERSEDER.

All code provisions, ordinances, resolutions, rules and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

SECTION 13. PUBLICATION.

A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

SECTION 14. EFFECTIVE DATE.

This Ordinance shall be effective and in full force immediately upon its passage and approval.

ORDINANCE NO. 2024- 18

AN ORDINANCE AMENDING CHAPTER 22, SECTION 22-3 OF THE MUNICIPAL CODE, VILLAGE OF STICKNEY, ILLINOIS REGARDING BUSINESS LICENSE REGULATIONS

WHEREAS, the Village of Stickney (the “Village”) is a home rule municipal corporation in accordance with Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970; and

WHEREAS, the Village has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs, and to review, interpret, and amend its ordinances, rules, and regulations; and

WHEREAS, the Village President (the “President”) and the Board of Trustees of the Village (the “Village Board” and with the President, the “Corporate Authorities”) are committed to ensuring the health, safety and welfare of Village residents; and

WHEREAS, the Village regulates the operation of the businesses within the Village; and

WHEREAS, currently, the Municipal Code, Village of Stickney, Illinois (the “Village Code”) does not impose penalties for businesses operating without business licenses within the Village; and

WHEREAS, based on the foregoing, the Corporate Authorities have determined that it is in the best interests of the Village and its residents to amend Chapter 22, Section 22-3 of the Village Code as set forth below;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, as follows:

**ARTICLE I.
IN GENERAL**

SECTION 1. INCORPORATION CLAUSE.

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preambles to this Ordinance are full, true and correct and do hereby, by reference, incorporate and make them part of this Ordinance as legislative findings.

SECTION 2. PURPOSE.

The purpose of this Ordinance is to amend Chapter 22, Section 22-3 of the Village Code to impose penalties for operating a business without a license within the Village and to authorize the President or his designee to take all actions necessary to carry out the intent of this Ordinance.

**ARTICLE II.
AMENDMENT OF CHAPTER 22, SECTION 22-3 OF THE MUNICIPAL CODE, VILLAGE OF STICKNEY, ILLINOIS**

SECTION 3.0. AMENDMENT OF CHAPTER 22, SECTION 22-3.

That the Village Code is hereby amended, notwithstanding any provision, ordinance, resolution, or Village Code section to the contrary, by amending Chapter 22, Section 22-3, which Section shall be amended as follows:

Sec. 22-3. - License.

(a) Required.

(1) No person shall conduct or maintain any of the businesses mentioned in this Code without first obtaining a license therefor.

(2) No person shall operate or maintain, within the village, any automatic vending machine for the sale of music, amusement, or any merchandise, nor sell or have on his premises any automatic vending machine and offer to sell any such item by means of an automatic vending machine or amusement device, without first having obtained a license for each of such mechanical machines.

(3) No person shall permit to be operated or maintained on premises under his control any automatic vending machine as described in subsection (a)(2) of this section which does not have a license attached to such machine as required by this Code.

(b) Signatures. Each license or permit issued shall bear the signatures of the mayor and clerk in the absence of any provision to the contrary.

(c) Penalties. A minimum fine of \$250.00 and a maximum fine of \$750.00 shall be imposed for violations of this section. Each day that the violation is not corrected constitutes a separate offense.

(d) Closure. Additionally, any business operating without a license must immediately cease operation until the license required by this section is issued. The Village may order the closure of the business for engaging in unlicensed business activity or failing to pay license fees and penalties related thereto by providing a ten (10) day notice to the business and posting a notice or sign at the business that it has been closed by order of the Village. The unlawful removal of any such sign shall be a violation of this section and a minimum fine of \$500.00 shall be imposed.

SECTION 3.1. OTHER ACTIONS AUTHORIZED.

The officers, employees and/or agents of the Village shall take all action necessary or reasonably required to carry out, give effect to and consummate the amendments contemplated by this Ordinance and shall take all action necessary in conformity therewith. The officers, employees and/or agents of the Village are specifically authorized and directed to draft and disseminate any and all necessary forms or notices to be utilized in connection with the intent of this Ordinance.

**ARTICLE III.
HEADINGS, SAVINGS CLAUSES, PUBLICATION,
EFFECTIVE DATE**

SECTION 4. HEADINGS.

The headings of the articles, sections, paragraphs and subparagraphs of this Ordinance are inserted solely for the convenience of reference and form no substantive part of this Ordinance nor should they be used in any interpretation or construction of any substantive provision of this Ordinance.

SECTION 5. SEVERABILITY.

The provisions of this Ordinance are hereby declared to be severable and should any provision of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable and as though not provided for herein and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

SECTION 6. SUPERSEDER.

All code provisions, ordinances, resolutions, rules, and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

SECTION 7. PUBLICATION.

A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

SECTION 8. EFFECTIVE DATE.

This Ordinance shall be effective and in full force ten (10) days after its passage, approval and publication in accordance with applicable law.
