The Board of Trustees of the Village of Stickney met in regular session on Tuesday, April 18, 2023, at 7:07 p.m. in the boardroom located at 6533 W. Pershing Road, Stickney, Illinois.

Upon the roll call, the following Trustees were present: Trustees White, Milenkovic, Torres, Kapolnek and Hrejsa Absent: Trustee Savopoulos

Trustee Hrejsa moved, duly seconded by Trustee Kapolnek to approve the minutes of the regular board meeting held on Wednesday, April 7, 2023

Upon the roll call, the following Trustee voted: Ayes: Trustees White, Milenkovic, Torres, Kapolnek and Hrejsa Absent: Trustee Savopoulos Mayor Walik declared the motion carried.

Trustee White moved, duly seconded by Trustee Milenkovic that the bills, approved by the various committees of the Board, be approved for payment, and to approve warrants which authorize the Village Treasurer to draw checks to pay the bills, to be signed by the authorized signers, as provided for by the Ordinances of the Village of Stickney.

Upon the roll call, the following Trustee voted:
Ayes: Trustees White, Milenkovic, Torres, Kapolnek and Hrejsa
Absent: Trustee Savopoulos
Mayor Walik declared the motion carried.

Trustee Milenkovic moved, duly seconded by Trustee White to Pass and Approve Ordinance 2023-05, "An Ordinance Amending Chapter 14, Section 14-148 of the Municipal Code, Village of Stickney, Illinois Regarding Residential Parking Zones."

Upon the roll call, the following Trustee voted:
Ayes: Trustees White, Milenkovic, Torres, Kapolnek and Hrejsa
Absent: Trustee Savopoulos
Mayor Walik declared the motion carried.

Prior to the vote, Village Attorney Jessica Fese explained that this ordinance amends Chapter 14, Section 14-148 concerning parking on street sweeping days. There had been a section three that related to the 4100 and 4200 blocks of East Avenue and 7000 and 7100 blocks of 40<sup>th</sup> Place and had a different street sweeping day. We just got rid of that and now everyone will abide by what everyone else is doing and by the posted signs that are already there. It was just a redundancy.

Trustee Torres moved, duly seconded by Trustee Kapolnek to pass, and approve Ordinance 2023-06, "An Ordinance Authorizing and Approving the Purchase of a Certain Vehicle for the Police Department of the Village of Stickney."

Upon the roll call, the following Trustee voted: Ayes: Trustees White, Milenkovic, Torres, Kapolnek and Hrejsa Absent: Trustee Savopoulos Mavor Walik declared the motion carried.

MAYOR'S REPORT: The Mayor thanked the people for attending. The parking ordinance change was for Monday through Friday not Monday and Tuesday.

<u>CLERK'S REPORT</u>: The clerk reported on a question Governor Pritzker is having with the Census. The American Community Survey found that the Census findings of a reduction in Illinois' population is actually misleading. They show that Illinois was undercounted by hundreds of thousands. The Census has been contacted many times about potential adjustments to the state's count.

An update was given concerning the Cook County's Economic Interest filing.

A reminder was given concerning the May 2, 2023 Board meeting. It will be held at Saint Pius, 4300 Oak Park Avenue, at 6:00 when the TIF meeting will be held and at 7:00 for the Board meeting.

<u>Trustee White</u>: The Trustee provided Earth Day activities at Brookfield Zoo on April 22, 2023. A recycling site will be offered in the North parking lot.

<u>Trustee Milenkovic</u>: The Trustee has been coordinating with Public Works Director Joe Lopez concerning the Arbor Day plans for April 22, 2023. We must have an event such as this to maintain our Tree City status. Hopefully, the Mayor will join the activities at both grammar schools.

The trees picked for this year's lottery will be: Sterling Silver Linden Greenspire Linden Corinthian Little Leaf Linden

The next Midway Noise Compatibility quarterly meeting will be on April 27, 2023. The Mayor asked about the amount of trees available in the lottery. The Trustee responded that it depends on how many people apply for a tree. Public Works Supervisor Joe Lopez is in charge of this program.

Trustee Hrejsa: The compost available from the MWRD is currently on hold for this year. The Trustee gave a warning about a member of the Shriners organization he belongs to has been hacked. There are emails going from him asking people to purchase gift cards and forward them to a fraudulent address. He continued telling about a Stickney resident that was defrauded. He provided a warning to people about sending money to people you do not know. The Mayor asked him to go to the Senior Club to talk to the seniors about this type of scams.

<u>Trustee Kapolnek:</u> He reminded people that the May  $2^{nd}$  meeting will be held at Saint Pius Church at 6:00 p.m.

<u>Trustee Lea Torres:</u> We were told about the plans for Cinco De Mayo on April 30<sup>th</sup>. 2:00 p.m. to 7:00 p.m. at 43<sup>rd</sup> and Ridgeland. Anyone can come to this event. She informed us of the food and festivities you will find there. The Mayor thanked her and Trustee Hrejsa for all the work they have done coordinating this event.

#### **DEPARTMENT REPORTS:**

Police Chief James Sassetti: The Chief reported on our newest police dog. We were granted a dog through the Department of Justice. The officer that has been in Pennsylvania training with the dog is completing his fifth week. The dog is one ½ year old Belgian Malinois. He will be back next Friday. His first shift will be on May 5th. We will be introducing him at the May 16th meeting.

Public Works Director Joe Lopez: The Mayor remarked that the parks have been cleaned up. The ball field has been prepared and fertilized. The baseball/soccer parade will be on May 13th. O'Reilly Park looks good. The clerk commented that she sent Joe Lopez a picture of a disk swing that she saw while downtown last week. She asked for one to be installed in Ridgeland Park that needs some new equipment. The Mayor and Trustee White said that we have budgets coming up and they could consider it.

There being no further business, Trustee White moved, duly seconded by Trustee Milenkovic that the meeting be adjourned. Upon which the Board adopted the motion at 7:29 p.m.

#### ORDINANCE NO. 2023-<u>07</u>

### AN ORDINANCE ADOPTING CHAPTER 66, SECTION 66-33 OF THE MUNICIPAL CODE, VILLAGE OF STICKNEY, ILLINOIS REGARDING TEMPORARY SIGNS

WHEREAS, the Village of Stickney (the "Village") is a home rule municipal corporation in accordance with Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970; and

**WHEREAS,** the Village has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs, and to review, interpret, and amend its ordinances, rules, and regulations; and

**WHEREAS,** the Village President (the "President") and the Board of Trustees of the Village (the "Village Board" and with the President, the "Corporate Authorities") are committed to ensuring the health, safety and welfare of Village residents; and

**WHEREAS,** currently, the Municipal Code, Village of Stickney, Illinois (the "Village Code") does not contain regulations regarding signage for special events within the Village ("Temporary Signs"); and

**WHEREAS**, the Corporate Authorities recognize the need to establish regulations for the permitting, placement, and removal of Temporary Signs (the "Regulations"); and

**WHEREAS,** based on the foregoing, the Corporate Authorities have determined that it is in the best interests of the Village and its residents to adopt Regulations as they relate to Temporary Signs within the Village; and

**WHEREAS**, based upon the foregoing, the Corporate Authorities have determined that it is necessary, advisable and in the best interests of the Village and its residents to adopt Chapter 66, Section 66-33 of the Village Code as set forth below;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, as follows:

### ARTICLE I. IN GENERAL

#### SECTION 1. INCORPORATION CLAUSE.

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preambles to this Ordinance are full, true and correct and do hereby, by reference, incorporate and make them part of this Ordinance as legislative findings.

#### SECTION 2. PURPOSE.

The purpose of this Ordinance is to adopt Chapter 66, Section 66-33 of the Village Code to adopt Regulations for Temporary Signs and to authorize the President or his designee to take all actions necessary to carry out the intent of this Ordinance.

# ARTICLE II. ADOPTION OF CHAPTER 66, SECTION 66-33 OF THE MUNICIPAL CODE, VILLAGE OF STICKNEY, ILLINOIS

#### SECTION 3.0. ADOPTION OF CHAPTER 66, SECTION 66-33.

That the Village Code is hereby amended, notwithstanding any provision, ordinance, resolution, or Village Code section to the contrary, by adopting Chapter 66, Section 66-33, which Section shall be amended as follows:

#### Sec. 66-33. – Special Event Signs

- (A) Special Event Signs. Special event signs shall mean any sign or signboard advertising a special event for any charitable, religious, or civic purpose. This Section shall not apply to special event signs on private property, and does not apply to political and/or campaign signs. No banners are permitted under this Section. Special event signs specifically exclude garage or yard sale signs.
- (B) Size; Number; Location. Special event signs located at public intersections or on Village owned parkways may not exceed three feet by three feet in area, and a maximum of twelve (12) signs may be posted in accordance with this Section. Any special event signs that impede pedestrian or motorist visibility may be removed by the Village without prior notice. No special event signs shall be affixed to any Village building, light pole, or other structure.
- (C) Posting And Removal of Signs. A special event sign may be posted not more than seven (7) calendar days before the event. All special event signs shall be removed by the owner within twenty-four (24) hours after the conclusion of the event. Any special event signs may thereafter be disposed of by the Village.
- (D) Penalty; Sign Removal. A violation of this Section shall result in a penalty of \$250.00 per occurrence per day. The Village may remove and dispose of the any and all special event signs that are in violation of this Section.

#### SECTION 3.1. OTHER ACTIONS AUTHORIZED.

The officers, employees and/or agents of the Village shall take all action necessary or reasonably required to carry out, give effect to and consummate the amendments contemplated by this Ordinance and shall take all action necessary in conformity therewith. The officers, employees and/or agents of the Village are specifically authorized and directed to draft and disseminate any and all necessary forms or notices to be utilized in connection with the intent of this Ordinance.

# ARTICLE III. HEADINGS, SAVINGS CLAUSES, PUBLICATION, EFFECTIVE DATE

#### SECTION 4. HEADINGS.

The headings of the articles, sections, paragraphs and subparagraphs of this Ordinance are inserted solely for the convenience of reference and form no substantive part of this Ordinance

nor should they be used in any interpretation or construction of any substantive provision of this Ordinance.

#### SECTION 5. SEVERABILITY.

The provisions of this Ordinance are hereby declared to be severable and should any provision of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable and as though not provided for herein and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

#### SECTION 6. SUPERSEDER.

All code provisions, ordinances, resolutions, rules, and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

#### SECTION 7. PUBLICATION.

A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

#### SECTION 8. EFFECTIVE DATE.

This Ordinance shall be effective and in full force ten (10) days after its passage, approval and publication in accordance with applicable law.

A RESOLUTION APPOINTING CERTAIN MEMBERS OF THE BOARD OF TRUSTEES AND CERTAIN OFFICERS, EMPLOYEES AND OFFICIALS OF THE VILLAGE OF STICKNEY TO CERTAIN POSITIONS FOR THE VILLAGE OF STICKNEY, COUNTY OF COOK, STATE OF ILLINOIS.

WHEREAS, the Village of Stickney (the "Village") is a home rule municipal corporation in accordance with Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970; and

WHEREAS, the Village has the authority to adopt ordinances and resolutions and to promulgate rules and regulations that pertain to its government and affairs, and to review, interpret and amend its ordinances, resolutions, rules and regulations; and

**WHEREAS**, the Village President (the "President") and the Board of Trustees of the Village (the "Village Board" and with the President, the "Corporate Authorities") are committed to ensuring the health, safety and welfare of Village residents; and

**WHEREAS**, the Village President (the "President") and the Board of Trustees of the Village (the "Village Board" and with the President, the "Corporate Authorities") have determined that it is necessary for conducting Village business and for the effective administration of government to appoint certain members of the Village Board ("Trustees") to specified committees; and

**WHEREAS**, the Corporate Authorities have further determined that it is necessary to appoint certain persons as officers, employees and officials to specific positions, boards, commissions and/or committees within the Village; and

WHEREAS, the Corporate Authorities find that it is in the best interests of the Village to make the specified appointments (the "Appointments"), which are set forth in Exhibit A, attached hereto and incorporated herein;

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, as follows:

### ARTICLE I. IN GENERAL

#### Section 1.0 Findings.

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preambles to this Resolution are full, true and correct and do hereby, by reference, incorporate and make them part of this Resolution as legislative findings.

#### Section 2.0 Purpose.

The purpose of this Resolution is to authorize the President to appoint the Trustees to the specified committees and to appoint certain persons as officers, employees and officials to specific positions, boards, commissions and/or committees within the Village, as set forth in Exhibit A, and to take all steps necessary to carry out the terms of the Appointments.

#### Section 3.0 Effectiveness and Term of Appointments.

The Appointments as set forth in Exhibit A are effective immediately and shall expire at 11:59 p.m. on April 30, 2024, or at such other time the President deems necessary, unless otherwise specified in Exhibit A. All prior appointments to the specific positions, boards, commissions and/or committees specified in Exhibit A are hereby removed from their prior appointments upon passage of this Resolution.

### ARTICLE II. AUTHORIZATION

#### Section 4.0 Authorization.

That the Corporate Authorities hereby authorize, approve and, as applicable, consent to the Appointments as set forth in Exhibit A, which is attached hereto and incorporated herein.

# ARTICLE III. HEADINGS, SAVINGS CLAUSES, PUBLICATION, EFFECTIVE DATE

#### Section 5.0 Headings.

The headings of the articles, sections, paragraphs and subparagraphs of this Resolution are inserted solely for the convenience of reference and form no substantive part of this Resolution nor should they be used in any interpretation or construction of any substantive provision of this Resolution.

#### Section 6.0 Severability.

The provisions of this Resolution are hereby declared to be severable and should any provision of this Resolution be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable and as though not provided for herein, and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

#### Section 7.0 Superseder.

All code provisions, ordinances, resolutions, rules and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

#### Section 8.0 Publication.

A full, true and complete copy of this Resolution shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

#### Section 9.0 Effective Date.

This Resolution shall be effective and in full force immediately upon passage and approval.


