**Trustee Kapolnek moved, duly seconded by Trustee Savopoulos to approve the minutes of the regular board meeting held on Tuesday, August 17, 2021.**

**MAYOR'S REPORT:** The Mayor welcomed all the students from Reavis High School that were in attendance. A thank you was extended to all those who helped at Family Day. It was a perfect day. There were so many volunteers we had to turn some away. Trustee Savopoulos explained that people were disappointed because he couldn't get the potatoes to make his famous potato pancakes because Sysco Food Products was on strike. A list of the Trustees that helped was given.

**CLERK'S REPORT:** The clerk read information concerning the new legislative maps detailing the political boundaries for the next ten years. The Illinois Republicans, the Mexican American Legal Defense and Education Fund sued the Democrats in Federal Court saying that the maps diminish the voice of minority populations. It could be December or even January before the court decides on the case.
