Trustee Milenkovic moved, duly seconded by Trustee Lazansky, to approve the minutes of the previous budget hearing meeting held on July 19, 2016 as submitted by the clerk.

President Morelli declared the motion carried.

Prior to the vote Trustee Lazansky opened a discussion. He asked, "Why was that meeting called any how and why wasn't I informed of that meeting?" Trustee White told him, "It was in your mailbox." Trustee Lazansky said, "I was never notified." A group of trustees told him, "You were." Trustee White again said, "It was in your mailbox." Trustee Lazansky responded, "It doesn't matter." "I wasn't called." "I wasn't told about this incident." "I was never notified." "I was never called." "It was sitting in there for two days." Trustee Hrejsa told him, "It was in there for two

weeks." The clerk informed him, "It went out the Thursday prior to the meeting." Trustee Lazansky asked, "Why was the meeting called." The clerk said, "I can't tell you that, but I don't have your phone number. I have no contact. . . ." Trustee Lazansky told her, "They have it in the office. You could have reached me on the computer. Oh yeah, I don't have a computer." Trustee White told him, "You don't have an email address." Trustee Lazansky replied, "I gave the clerk my home email address." Trustee Savopoulos said, "You have to start showing up at the village hall." Trustee Lazansky said, "I do, two hours—three hours." The clerk told him, "The packets went out." Trustee Savopoulos said, "You can't complain when you don't show up to pick up your mail." Trustee Lazansky said, "I picked up my mail, it wasn't in the box. It was gone. What was the meeting about?" Trustee Savopoulos answered him, "It was to rescind the payment for the prosecution." Trustee Lazansky asked, "Why was that brought about? Was there a reason?" Trustee Savopoulos told him, "Because we don't have a prosecutor." Trustee Lazansky responded, "Oh, so that is what the meeting was about." Trustee White then said, "Now that we have a full board, you wanted to take a vote like the last time, do you want to vote who the prosecutor is today?" Trustee Lazansky said, "It is not on the agenda." Trustee White told him, "It wasn't on the agenda the last one either but you wanted to call for a vote." Trustee Lazansky said, "And, they denied it too, that is fine, I had no problems with that." Trustee White asked, "Do you have any other questions about this discussion? Can we call for a vote?"

Trustee White moved, duly seconded by Trustee Savopoulos, to approve the payment of the bills.

Trustee Milenkovic moved, duly seconded by Trustee Savopoulos, to pass and approve Ordinance 2016-18, "An Ordinance Amending Chapter 58, Sections 58-1, 58-3 and 58-5 and Adopting Chapter 58, Section 58-7 of the Municipal Code, Village of Stickney, Illinois Regarding Peddlers and Solicitors.

Upon the roll call, the following Trustees voted:

Ayes, Trustee Fuentes, Hrejsa, Lazansky, Milenkovic, Savopoulos and White

Nays: None

President Morelli declared the motion carried.

Prior to the vote Trustee Lazansky asked Village Attorney Mike Del Galdo what this ordinance change was all about. Village Attorney Mike Del Galdo explained, "This amends the current solicitation ordinance. It adds that in addition to the name, address and telephone number of the person or corporation that is applying, they have to list their state issued license number, and this presumes that they are a corporation that is licensed by the state. It limits someone getting a license if they have citations under the Village Code. It raises the registration fee from the current

fee of \$250.00 to \$500.00. It sets forth currently that any registration can be revoked by the president or the chief of police and adds the majority vote of the Board of Trustees. It makes it unlawful for any solicitor or peddler to enter private property where there is a No Solicitation sign. It limits the period of time the permit is valid to 21 calendar days. It limits the number of licenses the peddler and/or solicitor can obtain in a calendar year to one. It limits the number peddler and /or solicitor licenses to five. The penalty for violation of this section shall be fined not less than \$250 or more than \$750.00 for each offense.

Trustee Savopoulos moved, duly seconded by Trustee White to pass and approve Ordinance 2016-19, "An Ordinance Granting a Special Use Permit for the Property Commonly Known as 4433 S. Harlem Avenue."

PRESIDENT REPORT: None

CLERKS' REPORT: None

TRUSTEES' REPORTS: Trustee Fuentes gave the fire department report for the month of July, 2016 as follows: Ambulance calls: 79; Mutual Aid Calls: 8; Service Calls: 1; Fire Calls: 8; Building Fire: 1; Car Fires: 0; Hazardous Condition Calls: 2; Motor Vehicle Accidents: 3; Brush/Trash Fire Calls: 0; Outside Equipment Fires: 1; Total calls for the month of July: 103; Total calls for 2016: 652.

In addition, Trustee Fuentes announced that the next Park & Rec meeting will be on Aug. 8, in the village hall. There is a Back to School clean up on August 20, at Haley Park at 9:00 a.m. They will go through all the parks in the village. They will go back to Haley Park for refreshments. There is a rain date of August 21. The Fall Fest will take place on September 10. Flyers will go out shortly.

Trustee Hrejsa reported on the Metropolitan Water Reclamation District naming contest naming a bio-solid. The bio-solid now can sold to the public. The entry deadline is August 30.

Trustee Milenkovic reported that he attended the Midway Noise Compatibility Commission meeting on July 28. It is their 20th anniversary. We have sound proofed 10,000 homes in 20 years. We are on phase 16 right now. The complaints so far this year are 54,343. Ninety-seven percent of them come from two addresses. No complaints from Stickney. In 2015, in the second quarter, the decibel level was at 52.2. The second quarter in 2016 it was at 54.9. Our 12 month average is 53.1 decibels. We need 60 decibels to get the schools done or 65 for the homes. They replaced the battery backup in the noise monitor located at 4308 Wenonah. If there is no power supply too it, it will last one month instead of one week.

Trustee Savopoulos informed us that as of July 31, 2016 the 50/50 sidewalk program was officially over. We have approximately 72 squares that will be replaced. Beth, our administrative assistant, will be mailing out letters by August 15, so we could collect the payment by September 15, from those who signed up. Hopefully the work will start in October.

Trustee White explained that he and Police Chief Sladetz filled out an on-line application for a grant for a medical lock box. The box will be kept in the police station. Trustee White contacted Congressman Lipinski for guidance for the grant. Once the application is accepted, you will be able to drop your expired drugs off in the police department.

DEPARTMENT REPORTS: Police Chief Sladetz told us that on August 4, there will be a preliminary hearing in Springfield in front of the 911 Advisory Board. He will be attending along with Deputy Chief Jaczak and our Telecommunication Supervisor Dave Gesiorski. There will be a more extensive meeting in reference to our waiver on August 29. We will give our testimony. Council will be required at that meeting. We should know by that time what will happen to our dispatch center.

Public Works Supervisor Jeff Boyajian informed us that last week we were notified by the police department that there was water coming out of the center of the street at Pershing and 58th. The location included water mains for McCook, Brookfield, North Riverside and Stickney. It took five hours to figure out it was the Stickney water main that burst. In addition there was another water main that broke in the Jewel Store parking lot. It was believed that a tractor trailer hit a fire hydrant turning into the parking lot causing the water main to break and eventually cause a sink hole.

Trustee Fuentes moved, duly seconded by Trustee Hrejsa to adjourn into executive session at 7:20 p.m.

ORDINANCE NO. 2016- 20

AN ORDINANCE AMENDING CHAPTER 50, SECTION 50-38 OF THE MUNICIPAL CODE, VILLAGE OF STICKNEY, ILLINOIS REGARDING CANNABIS

WHEREAS, the Village of Stickney (the "Village") is a home rule municipal corporation in accordance with Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970; and

WHEREAS, the Village has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs, and to review, interpret and amend its ordinances, rules and regulations; and

WHEREAS, the Village President (the "President") and the Board of Trustees of the Village (the "Village Board" and with the President, the "Corporate Authorities") are committed to protecting the health, welfare and safety of individuals residing in and visiting the Village; and

WHEREAS, certain penalties and fees set forth in the Cannabis Control Act (the "Cannabis Control Act") (720 ILCS 550/1) were recently amended by Public Act 099-0697 (the "Act"); and

WHEREAS, the Corporate Authorities have determined that it is in the best interests of the Village and its residents to amend the Municipal Code, Village of Stickney, Illinois (the "Village Code") to reflect the penalties and fees for possession of cannabis set forth in the Cannabis Control Act, as amended; and

WHEREAS, in light of the foregoing, the Corporate Authorities have determined that it is in the best interests of the Village and its residents to amend Chapter 50, Section 50-38 of the Village Code as set forth herein;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, as follows:

ARTICLE I. IN GENERAL

SECTION 1. INCORPORATION CLAUSE.

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preambles to this Ordinance are full, true and correct and do hereby, by reference, incorporate and make them part of this Ordinance as legislative findings.

SECTION 2. PURPOSE.

The purpose of this Ordinance is to amend Chapter 50, Section 50-38 of the Village Code to amend the penalties and fees for possession of cannabis to reflect those set forth in the Cannabis Control Act, as amended, and to authorize the President or his or her designee to take all actions necessary to carry out the intent of this Ordinance.

ARTICLE II.
AMENDMENT OF CHAPTER 50, SECTION 50-38 OF THE MUNICIPAL CODE, VILLAGE OF
STICKNEY, ILLINOIS

SECTION 3.0. AMENDMENT OF CHAPTER 50, SECTION 50-38.

That the Village Code is hereby amended, notwithstanding any provision, ordinance, resolution or Village Code section to the contrary, by amending Chapter 50, Section 50-38, which Section shall be amended as follows:

Sec. 50-38. – Possession of cannabis.

(a) It shall be unlawful for any person to possess cannabis, except as set forth in the Compassionate Use of Medical Cannabis Pilot Program Act (410 ILCS 130/1 et seq.).

(b) Cannabis includes marijuana, hashish and other substances which are identified as including any parts of the plant *Cannabis Sativa*, whether growing or not; the seeds thereof, the resin extracted from any part of such plant; and any compound, manufacture, salt, derivative, mixture or preparation of such plant, its seeds, or resin, including tetrahydrocannabinol (THC) and all other cannibal derivatives, including its naturally occurring or synthetically produced ingredients, whether produced directly or indirectly by extraction, or independently by means of chemical synthesis or by combination of extraction and chemical synthesis; but shall not include the mature stalks of such plant, fiber produced from such stalks, oil or cake made from the seeds of such plant, and other compound, manufacture, salt, derivative, mixture, or preparation of such mature stalks (except the resin extracted therefrom), fiber, oil, or cake, or the sterilized seed of such plant which is incapable of germination.

(c) A police officer may, in lieu of filing a complaint or arresting a violator, issue to the violator a citation (notice to appear or "P" ticket) allowing the violator to settle and compromise the violation claim by paying to the village the amount set forth as follows, not more than ten days after the time such violation was committed:

Two grams or less	150.00
More than two grams and not more than ten grams	250.00 <u>200.00</u>
More than ten grams and not more than 20 grams	400.00
More than 20 grams and not more than 30 grams	500.00

If the person to whom a citation was issued fails to settle within ten days, the amount of settlement prior to a court appearance shall be double the amount enumerated in this subsection.

(d) If the person to whom the citation was issued fails to settle and pay such violation claim, proceedings shall be instituted in the county circuit court against the violator. If a

fine is imposed by the court, such fine shall be not less than the amount set forth in this subsection as the settlement amount, but not more than \$500.00.

SECTION 3.1. OTHER ACTIONS AUTHORIZED.

The officers, employees and/or agents of the Village shall take all action necessary or reasonably required to carry out, give effect to and consummate the amendments contemplated by this Ordinance and shall take all action necessary in conformity therewith.

ARTICLE III. HEADINGS, SAVINGS CLAUSES, PUBLICATION, EFFECTIVE DATE

SECTION 4. HEADINGS.

The headings of the articles, sections, paragraphs and subparagraphs of this Ordinance are inserted solely for the convenience of reference and form no substantive part of this Ordinance nor should they be used in any interpretation or construction of any substantive provision of this Ordinance.

SECTION 5. SEVERABILITY.

The provisions of this Ordinance are hereby declared to be severable and should any provision of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable and as though not provided for herein and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

SECTION 6. SUPERSEDER.

All code provisions, ordinances, resolutions, rules and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

SECTION 7. PUBLICATION.

A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

SECTION 8. EFFECTIVE DATE.

This Ordinance shall be effective and in full force ten (10) days after its passage, approval and publication in accordance with applicable law.

As you know, the air pak grant was awarded. An air pak committee was formed and the did research, now it is time to make the purchase. After presentations from Scott and MSA, and looking at other brands, the committee advised that purchasing the Scott air paks would be the best option. We have been using Scott air paks here for nearly 50 years. SFD personnel are trained in the use and maintenance of this brand of air pak. Continued use of the Scott product is advantageous in respect to safety, training and efficiency.

Scott dealers have sales territories, prices are negotiated directly with the manufacturer for quantity discounts. See the attached quote.

Per the village legal counsel, the Illinois Municipal Code provides that a municipality may waive any applicable competitive bidding requirements for any work or other public improvement upon a vote of two-thirds of all the trustees currently holding office. (See 65 ILCS 5/8-9-1).

Although competitive bidding requirements may not be applicable to this purchase, out of an abundance of caution at least two-thirds of the members of the Village Board should vote to waive all competitive bidding requirements at an open meeting prior to the purchase of these Scott air paks.
