MAYOR'S REPORT: Mayor Walik read A Proclamation recognizing Arbor Day and stated that Stickney is a Tree City USA community and Trustee Milenkovic over sees the Tree Board. We will be giving away 15 trees for tree lottery and two (2) of those trees will go to Home and Edison school.

Trustee White: The news just reported that the second installment for property taxes will be delayed up to six months, the issue with that is the first installment for the fall might end up being due at the same time, but it's possible that there would be another grace period for that if it happens.

Trustee Kapolnek: Just a reminder that Friday, April 22 is Earth Day. The Midway Noise Compatibility meeting is next week.

Trustee Torres: Thank you to everyone who helped with the Easter Egg hunt. The tweek egg hunt had about 26 kids and it went well. Saturday's egg hunt had approximately 146 kids, the day was sunny but cold. Everything went great. About 1500 eggs were put out and it was over in about 10 minutes. Thank you to Mayor Walik the police and public works for their help.

Trustee Hrejsa: Wanted to also say that the Easter egg hunt went well. It was crazy but the kids had a great time.

DEPARTMENT REPORTS:

Fire Chief Jeff Boyajian:

The new ambulance is almost ready, they are just waiting for the graphics and for the radio so it can be installed. Fire inspector taught CPR classes at Motion Industries and Little League.

Police Chief James Sasseti: Since the newsletter went out, there has been an increase in tip 411 which is a way to send an anonymous tip to the Stickney Police Department. Save the date for April 30th, MWRD will be holding a drug take back event between 10am – 2pm. They will be handing out free tree saplings and bags of compost.

Public Works Supervisor: Mayor Walik spoke for DPW supervisor as he was on vacation. Just a reminder that street sweeping started don't forget to move your car so you don't get a ticket. Great job to DPW employees who have been working cleaning up Ridgeland Ave. and cleaning up the baseball and soccer fields. This year 150 kids are registered for baseball and 250 kids for soccer. This is the most ever that have signed up.
