**The Board of Trustees of the Village of Stickney met in regular session on Tuesday, March 3, 2015 at 7:00 p.m. in the Stickney Village Hall, 6533 W. Pershing Road, Stickney, Illinois.**

**Upon the roll call, the following Trustees were present:**

**Present: Trustees DeLeshe, Gomez, Savopoulos, Sleigher and White**

**Absent: Trustee Lazansky**

**Trustee Sleigher moved, duly seconded by Trustee Savopoulos to approve the minutes of the previous regular board meeting held on February 17, 2015.**

**Upon the roll call, the following Trustees voted:**

**President Morelli declared the motion carried.**

**Prior to the vote, Attorney Donald Kreger explained that he issued a corrected copy of the ordinance to correct some typing errors.**

Trustee Sleigher moved, duly seconded by Trustee Savopoulos to approve Resolution 07-2015, "A Resolution Urging the Governor and General Assembly to Protect Full Funding of Local Government Distributive Fund Revenues"

Upon the roll call, the following Trustees voted:

President Morelli declared the motion carried.

Trustee Gomez moved, duly seconded by Trustee White to grant permission to Misericordia to Conduct their Jelly Belly Candy Days Fundraiser Event on April 24 & 25.

President Morelli declared the motion carried.

**MAYOR'S REPORT:** Trustee Lazansky asked the mayor to explain that the reason he was not at this meeting was that he had rotary cuff surgery on his shoulder. She reminded everyone that this Saturday, March 7, 2015 at 11:00 a.m. to 1:00 at the Stickney/Forest View Library, they will be conducting the St. Baldrick's Event to shave heads for charity. Police Chief John Sladetz will be the celebrity having his head shaved. An invitation was extended to all.

The mayor then proceeded to announce the following: "Recently I had submitted to the Board of Trustees the appointments of seven people to fill out the Parks and Recreation Committee Commission. " "Based on the Board's failure to take any action to approve the appointments, I am assuming that the commission will not be operating during the near future, therefore, I have decided to select the same people to act as Parks and Recreation advisors for me, with the hope that they will help to review, supervise and approve the Parks and Recreation for the Village of Stickney." "I am not seeking the approval of the Village Board for any of my selections here today." "I would like to once again have those that are here today, because you have been here four different times already, Mike Salzar couldn't be here today, Mark Kusper would you please stand up." At this point Trustee White interjected that this was not on the agenda. Mayor Morelli said, "No, this is under my report and I am not needing your approval." Trustee White then said, "Can I say something please?" "This Board has no intention of not giving you your Parks and Recs committee." "This Board has a problem with you appointing three of your political candidates six weeks before an election." "If you wanted to remove them from your picks, you would have had your Parks and Rec Board already, but you chose not to do that." Mayor Morelli responded, "I didn't hear anything mentioned about any of that." Trustee White answered, "You're the only one that doesn't know." "It seems like everybody else knew." Mayor Morelli said, "None of my board knew that." Trustee White added, "It is

just unethical six weeks before an election." Mayor Morelli went on to say, "These are people who have been helping me." Trustee Savopoulos injected this comment, "These are people who will have to resign because they can't sit on that board." Mayor Morelli answered, "That's fine, I need somebody to help now because you've been on the Board and you've done nothing." Trustee Savopoulos stated, "I have done nothing?" Mayor Morelli answered, "Yes, you haven't. You show up the day of something." Trustee Savopoulos remarked, "Really, you know what, we tried to fix the curb out in front here and you....." Mayor Morelli responded, "Right, and we'll take care of all of that." "I am not talking about curbs right now Sam." "I am talking about my people." Trustee Savopoulos went on, "Right now you are sabotaging yourself, so don't blame me." Mayor Morelli responded, "No, I'm not sabotaging anybody." Trustee White added, "We're not talking about the budget right now either." "But, I tell you what, I wish you would have wanted to put 20% of your effort towards that budget when we wanted to change it as the effort you are putting towards the Parks and Rec committee, an Advisory Committee, an Advisory Committee." Mayor Morelli announced, "I have nothing more to say to you." Trustee Savopoulos said, "You had nothing to say about the budget." Mayor Morelli finally said, "That is fine." "I'm not talking about the budget." She went on to announce her committee, Mark, Maryann Schimmel is not here, Sheri Young, Ed Dabrowski he's not here, Darrio Ramirez is not here and Magan Carpenter. Thank you very much for being here tonight and I'm looking forward to working with all of you.

**CLERK'S REPORT:** The clerk provided information she received on an EPA permit request application for Waste Management Metro located at 3815 S. Laramie. The description of the project stated: Update Closure Plan and Closure Cost Estimate to reflect currently permitted operations. Public Works Supervisor Jeff Boyajian mentioned that he placed a phone call to the EPA for an explanation of the project. He is waiting for them to call him back. In addition, the Clerk gave information concerning a School District 103 candidate's forum on March 10, 2015 at George Washington Middle School at 7:00 p.m. facilitated by the League of Women Voters.

DEPARTMENT REPORTS: Fire Chief Larry Meyer reminded people that on Saturday, they should move their clocks up. The fire department purchased some ice cleats to prevent falls on ice during large fires. He mentioned that firefighters have fallen on ice during large fires. March is Severe Weather Awareness Month. Be aware and be prepared. We were also told about an accident involving our hook and ladder truck. The fire alarm went off at 1:30 in the morning at Koppers Industries. The ladder truck was responding when it was hit. No one was hurt. The other driver was operating his vehicle on a revoked driver's license. There is a possibility that our insurance company may have to bite the bullet on this one. The \$15,000 in repairs includes the front door and fender, it took out the side glass from the bearing axle oil, and there were pieces of the guy's car imbedded between the tire and the wheel. Thursday morning the truck is going to a specialty repair shop in St. Johns, Indiana. It will probably be out of service for two weeks. He was glad no one was hurt including the guy driving the car.

## **ORDINANCE NO. 2015-03**

### **AN ORDINANCE AMENDING SECTIONS 18-101 AND 18-102 OF CHAPTER 18 ENTITLED "BUILDINGS AND BUILDING REGULATIONS" OF THE MUNICIPAL CODE OF THE VILLAGE OF STICKNEY (ADOPTION OF THE 2009 INTERNATIONAL BUILDING CODE)**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Stickney, Cook County, Illinois as follows:

**Section 1. Section 18-101**, "Adopted," of Article 1 entitled "Building Code" of Chapter 18 entitled "Buildings and Building Regulations" be and the same is hereby amended to read as follows:

**Sec. 18-101 Adoption of Building Code.** There is hereby adopted by reference, as if fully set out at length in this section, that publication known and designated as the International Building Code, 2009 Edition, including Appendix Chapters C, E, F, G, H, I and J, as published by the International Code Council as the Building Code of the Village of Stickney, Illinois, regulating and governing the conditions and maintenance of all property, buildings and structures; by providing the standards for supplied utilities and facilities and other physical things and conditions essential to ensure that structures are safe, sanitary and fit for occupation and use; and the condemnation of buildings and structures unfit for human occupancy and use and the demolition of such structures as herein provided; providing for the issuance of permits; and each and all of the regulations, provisions, penalties, conditions and terms of said Building Code, three copies of which are on file in the office of the Village Clerk with the following additions, insertions and deletions and changes to the Building Code set forth in Section 18-102 of this Chapter 18.

**Section 2. Section 18-102** "Definition " of article III entitled "Building Code" of Chapter 18 entitled Buildings and Building Regulations be and the same is hereby amended to read as follows:

**Section 18-102.** Additions, insertions, deletions and changes:

- A. Whenever the term Name of Jurisdiction is used, it shall mean the Village of Stickney.
- B. References to the establishment and duties and authority of the Board of Appeals shall not be effective and shall be deleted.
- C. The following sections or subsections of the Building Code are revised, deleted or added as indicated:

902.1 definition of Fire Area is hereby revised to read as follows:

The aggregate floor area bounded by the exterior walls of a building: regardless of fire walls, fire barriers, or fire resistance rated horizontal assemblies.

903.2 is hereby revised to read:

903.2 Where required. Approved automatic sprinkler systems in new buildings and structures shall be provided in the locations described in 903.2.1 through 903.2.12 as amended.

Approved automatic sprinkler systems shall be provided in existing buildings and structures when any of the following conditions exist:

1. A change of use occurs and the new use would require an automatic sprinkler system if it were a new building or structure.
2. When an addition is made to the building or structure resulting in or enlarging a fire area that would necessitate an automatic sprinkler system if it were a new building or structure.
3. When the building or structure receives alterations or improvements valued at or costing 50% or more of the replacement cost of the existing building or structure; or when 50% or more of the existing building or structure is being altered or improved.

903.2.1.1 item 1 is hereby revised to read:

1. The fire area exceeds 5,000 square feet.

903.2.1.3 item 1 is hereby revised to read:

1. The fire area exceeds 5,000 square feet.

903.2.1.4 item 1 is hereby revised to read:

1. The fire area exceeds 5,000 square feet.

903.2.3 Group E item 1 is hereby revised to read:

1. Throughout all Group E fire areas greater than 5,000 square feet in area.

903.2.4 is hereby revised to read:

903.2.4 Group F-1 and F-2. An automatic sprinkler system shall be provided throughout all buildings containing a Group F-1 or Group F-2 occupancy where one of the following conditions exists:

1. A Group F-1 or F-2 fire area exceeds 5,000 square feet.
2. A Group F-1 or F-2 fire area is located more than three stories above grade plane.
3. Deleted.

903.2.7 Group M, Item 1 is hereby revised to read:

1. A Group M fire area exceeds 5,000 square feet.

903.2.7 Group M is further revised by deleting Item 3.

903.2.9 Group S-1 is hereby revised to read:

903.2.9 Groups S-1 and S-2. An automatic sprinkler system shall be provided throughout all buildings containing a Group 5-1 or 5-2 occupancy where one of the following conditions exists:

1. A Group S-1 or S-2 fire area exceeds 5,000 square feet.
2. A Group S-1 or S-2 fire area is located more than three stories above grade plane.
3. Deleted.

903.2.9.1 items 1 and 2 are hereby revised to read:

1. Buildings having two or more stories above grade plane, including basements with a fire area containing a repair garage exceeding 5,000 square feet.
2. Buildings no more than one story above grade plane, with a fire area containing a repair garage exceeding 5,000 square feet.

903.2.10 Group S-2 enclosed parking garage item 1 is hereby revised to read:

1. Where the fire area of the enclosed parking garage exceeds 5,000 square feet.

903.3.5 Water Supplies is hereby revised to read:

903.3.5 Water Supplies. Water supplies for automatic sprinkler systems shall comply with this section and the standards referenced in 903.3.1. The potable water supply shall be protected against backflow in accordance with the requirements of this section and the Plumbing Code applicable to the Village of Stickney. Hydrant water flow data used for any sprinkler system shall be no more than one (1) year old.

The following subsection is hereby added:

903.3.8 Groups S and F speculative buildings and structures with ceilings of 25 feet or more. Where a building or structure of Use Group S or F with a ceiling height of 25 feet or more is proposed and no specific tenant is known, an ESFR sprinkler system designed for Class IV commodities stored on racks to the greatest possible storage height shall be provided.

The initial paragraph of 903.4.1 is hereby revised to read:

903.4.1 Monitoring. Alarm, supervisory and trouble signals shall be distinctly different and shall be automatically transmitted directly to the Stickney Fire Department Communications Center.

The following subsections are hereby added:

903.4.2.1 Outside Devices. Provide an outside audible horn or bell visual (75 cd clear strobe) device over the fire department connection.

903.4.2.2. Occupant notification. All sprinklered buildings shall be provided with occupant notification appliances.

903.4.2.3. Access to test valves. Fire sprinkling system inspectors test valves shall be accessible at all times and located no more than six (6) feet above the finished floor. On multiple riser systems test valves shall be marked as to which riser and area it tests.

903.4.3. Floor Control Valves is hereby revised to read:

903.4.3. Floor Control Valves. Approved supervised indicating control valves shall be provided at the point of connection to the riser on each floor in multiple story buildings. Provide floor control valves with water flow switches for each floor.

The following sections and subsections are hereby added:

903.4.4. Automatic Sprinklers. Where automatic sprinklers provide protection to an area with an approved flow switch interconnected to the fire alarm system, and the area is easily identifiable as to the location of the activation, additional automatic detectors are not required. When a building has numerous rooms protected by a zoned sprinkler system, additional smoke detectors shall be required to provide a more rapid means to identify the location of a fire.

903.3.5.3. Minimum Safety Factor. Provide a minimum 10% or 5 psi minimum safety factor, and the system demand shall be 5 psi minimum above the season low water flow test supply.

903.7. Hydraulic Name Plate. By each hydraulically calculated area, on each drawing provide a copy of the hydraulic name plate.

903.9. Fire Pump Test Header. Provide an outside test header on fire pump installations.

903.10. Private Fire Hydrants. Fire hydrants shall be provided around the perimeter of the building in 300 feet increments. A fire hydrant shall be located within 100 feet of the fire department connection on the fire protection water supply to the building. Fire flow requirements are subject to the provisions of Appendix B of the International Fire Code, 2009 Edition.

903.11. Outdoor Access. Provide an outdoor access to the sprinkler riser valve room and fire pump room.

903.12. Minimum separation of sprinkler valve room. Provide a minimum one(1) hour separation of sprinkler valve room.

903.13. Warehouse Storage Areas. In all storage areas exceeding 20,000 square feet and in all storage areas exceeding 12 feet in height, provide inside 2 ½ inch fire hose valves with 1 ½ inch reducer to a 1 ½ inch connection. Locate the valve at each door entrance to the warehouse and/or storage area. Provide additional 2 ½ inch fire hose valves so that no portion of the warehouse and/or storage area is more than 120 feet maximum travel distance to a fire hose valve. Show the locations of all obstructions and/or racks on the drawing.

The fire hose valves system pipings shall be:

1. A separate riser piping system.
2. The 2 ½ inch valves shall be supplied by a minimum of 4 inch with 2 ½ inch drops to each valve.
3. Where system pressures exceed 100 psi, provide reduced pressure field adjustable type valves.

907.1.4. Fire Alarm System. A fire alarm system shall be of the addressable type except when monitoring a single sprinkler riser and control valves.

The initial paragraph of 907.2. is hereby revised to read:

907.2. Where required – New Buildings and Structures. An approved fire alarm system installed in accordance with the provisions of this Code and NFPA 72 shall be provided in new buildings and structures in accordance with 907.2.1 through 907.2.24, and provide occupant notification in accordance with 907.6, unless other requirements are provided by other sections of this Code.

The following subsections are hereby added:

907.2.7.2. Multi-Tenant use. Multi-Tenant Use Group M Buildings will be “ring by tenant” activated by the fire sprinkler system flow switch

for that space of automatic fire detection and shall include a weatherproof clear outside strobe over the entrance to each tenant space as directed by the fire department. All outside strobes shall be 75 candela minimum.

907.2.24. Unsprinkled Buildings and Structures. An approved automatic alarm system shall be installed in all use groups not provided with an automatic sprinkler system. Automatic smoke detection shall be used except where ambient conditions would result in nuisance alarm conditions.

907.7.3.1. is hereby revised by adding the following:

All fire alarm control panels or full function annunciator panels shall be installed within ten (10) feet of the main entrance, or in locations approved by the fire department.

The following subsection is hereby added:

912.1.1. Fire department connections. All fire department connections shall be 4 inch story connections with 30 degree down turn.

1006.3 is hereby revised to add item 6 to read:

6. All rooms containing building fire sprinkler riser(s), fire pump(s) and fire control panel(s).

**Section 2. Effective Date.** This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

Resolution No. 08-2015

**A Resolution Authorizing the Execution of a Law Enforcement Mutual Aid Agreement and the Existence and Formation of the Illinois Law Enforcement Alarm System by Intergovernmental Cooperation.**

Whereas the Municipality of Stickney, of the State of Illinois (hereinafter "Municipality") is a Municipality of the State of Illinois and duly constituted public agency of the State of Illinois, and;

Whereas the Municipality, as a public agency of the State of Illinois, is authorized and empowered by the Constitution of the State of Illinois (Ill. Const. Art. VII, § 10) and the Illinois Intergovernmental Cooperation Act (5 ILCS 220/1 *et seq.*) to enter into intergovernmental agreements with other public agencies on matters of mutual concern and interest such as the provision of adequate law enforcement personnel and resources for the protection of residents and property falling within the jurisdiction of the Municipality, and;

Whereas the Municipality recognizes that certain natural or man-made occurrences may result in emergencies or disasters that exceed the resources, equipment and/or law enforcement personnel of a single given public agency, and;

Whereas, a given public agency can, by entering into a mutual aid agreement for law enforcement services and resources, effectively provide a broader range and more plentiful amount of law enforcement capability for the citizenry which it serves, and;

Whereas, in order to have an effective mutual aid agreement for law enforcement resources and services, this Municipality recognizes it must be prepared to come to the aid of other public agencies in their respective times of need due to emergencies or disasters, and;

Whereas, this Municipality recognizes the need for our specific Municipality to develop an effective mutual aid agreement for law enforcement services and resources upon which it may call upon in its time of need and is prepared to enter into a mutual aid agreement for law enforcement services and resources with other like-minded public agencies, and;

Whereas, this Municipality also recognizes the need for the existence of a public agency, formed by an intergovernmental agreement between two or more public agencies, which can serve to coordinate and facilitate the provision of law enforcement mutual aid between signatory public agencies to a mutual aid agreement for law enforcement services and resources, and;

Whereas, this Municipality has been provided with a certain "Law Enforcement Mutual Aid Agreement" which has been reviewed by the elected officials of this Municipality and which other public agencies in the State of Illinois are prepared to execute, in conjunction with this Municipality, in order to provide and receive law enforcement mutual aid services as set forth in the "Law Enforcement Mutual Aid Agreement," and;

Whereas, it is the anticipation and intention of this Municipality that this "Law Enforcement Mutual Aid Agreement" will be executed in counterparts as other public agencies choose to enter into the "Law Enforcement Mutual Aid Agreement" and strengthen the number of signatory public agencies and resources available from those public agencies, and;

Whereas, it is the anticipation and intent of this Municipality that the "Law Enforcement Mutual Aid Agreement" will continue to garner support and acceptance from other currently unidentified public agencies who will enter into the "Law Enforcement Mutual Aid Agreement" over time and be



considered as if all signatory public agencies to the "Law Enforcement Mutual Aid Agreement" had executed the "Law Enforcement Mutual Aid Agreement" at the same time,

Now, therefore, be it resolved by this Municipality/County as follows:

1. This Resolution shall be known as, and may hereafter be referred to as, the Resolution Authorizing the Execution of a Law Enforcement Mutual Aid Agreement and the Existence and Formation of the Illinois Law Enforcement Alarm System by Intergovernmental Cooperation.

2. The Resolution Authorizing the Execution of a Law Enforcement Mutual Aid Agreement and the Existence and Formation of the Illinois Law Enforcement Alarm System by Intergovernmental Cooperation shall be, and hereby is, enacted as follows:

- a. Authorization to enter into a Certain Agreement. The Mayor of this Municipality is hereby authorized to sign, execute and deliver the agreement known as the "Law Enforcement Mutual Aid Agreement" and thereby enter into an intergovernmental agreement with such other public agencies of the State of Illinois as are likewise willing to enter into said "Law Enforcement Mutual Aid Agreement" and recognize the existence and formation of the Illinois Law Enforcement Alarm System as set forth in the said "Law Enforcement Mutual Aid Agreement."
- b. Savings Clause. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any of the provisions of this Resolution.
- c. Effective Date. This Resolution shall be in full force and effect from and after its passage, approval and publication as provided by law.
