PRESIDENT'S REPORT: We learned that Phase 6 of the street repaving should get underway by early August. It shouldn't take very long. It is two blocks of Kenilworth, part of 41st Street that wasn't covered, and that bad section of 40th between Home and Harlem. And, the water tower should also be in the next month and should take about a month to do.

DEPARTMENT REPORTS:

Fire Chief Larry Meyer informed us that they had a successful "Fill the Boot" campaign. There was \$10,707.00 collected for the Muscular Dystrophy Association. Cicero held their All American Fest recently. Our department was involved in the water barrel competition where the water spray from a fire hose pushes a barrel back and forth on a cable. It takes a little bit of skill in hose handling practice. We won the competition and a silver trophy was awarded. Heat related problems were reported. A house collapsed in Maywood and another one in Melrose Park due to cracking dry ground and cracks in the walls. We are also having dry grass fires. The front lawn of a house on 43rd Street caught fire due to a lit cigarette. On July 4, a fire was caused by fireworks. If your yard catches on fire use your garden hose before the fire department gets there. There was a house in Stream Wood where a yard caught

on fire and spread to a fence then onto the house. He provided us with a reminder that our firefighters work under over-heating-conditions with this extreme heat when they are fighting fires.

The low bidder was Am-Coat Painting, submitting a bid in the amount of \$549,440.00, which was \$77,560.00 (or 12.37%) under the Engineer's Estimate of \$627,000.00.

Am-Coat Painting has performed a number of tank painting projects for our Office including the recent tank painting project for the South Stickney Sanitary District (SSSD) and their performance on these projects was found to meet the requirements of the contract specifications.

Therefore, we recommend that this Contract is awarded to Am-Coat Painting, 17201 S. Parker Road, Homer Glen, IL 60491, in the amount of \$549,440.00, based on their low bid proposal.

Enclosed is a copy of the "Tabulation of Bids" for the bids that were received and opened for the above-referenced project on July 17, 2011, at 7:00 p.m. Six (6) bids were received and checked for accuracy. Our review of the bids discovered some minor errors, which were corrected. These corrections, however, did not affect the resultant low bidder as shown.

The low bidder was Central Blacktop Co., Inc., submitting a bid in the amount of \$388,939.90, which was \$2,319.85 (0.59%) below the Engineer's Estimate of \$391,259.75.

Central Blacktop Co. Inc. is qualified by IDOT to perform this work. Therefore, we recommend that a Contract be awarded to Central Blacktop Company, Co. Inc., P.O. Box 2080, LaGrange, IL. 60525, in the amount of \$389,939.90 based on their submitted low bid proposal.

This project will include street paving improvements for the street locations shown on the attached project location map. This project will be funded by both IDOT Motor Fuel Tax (MFT) funds and Village Bond Funds.

RESOLUTION 08-2012

A RESOLUTION OF THE VILLAGE OF STICKNEY AUTHORIZING THE SUBMISSION OF A QUESTION CONCERNING THE SUPPLY OF ELECTRICITY TO THE ELECTORS AT THE NOVEMBER 6, 2012 GENERAL ELECTION

WHEREAS, THE Illinois Power Agency Act, 20 ILCS 3855/1-1 *et seq.*, authorizes the corporate authorities of a municipality to aggregate residential and small commercial retail electrical loads for the purchase of electricity pursuant to an opt-out program, provided that the voters of the municipality authorize the same by referendum at an election; and

WHEREAS, the Board of Trustees of the Village of Stickney has determined that the electors of the Village should have the opportunity to vote upon the municipal electricity aggregation program and that a proposition should be submitted at the November 6, 2012 General Election.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Village of Stickney, Cook County, Illinois as follows:

Section 1

That the following proposition be submitted to the voters of the Village of Stickney at the General Election to be held on November 6, 2012:

"Shall the Village of Stickney have the authority to arrange for the supply of electricity for its residential and small commercial retail customers who have not opted out of such program?"
