The Board of Trustees of the Village of Stickney met in regular session on Tuesday, May 17, 2016 at 7:00 p.m. in the Stickney Village Hall, 6533 W. Pershing Road, Stickney, Illinois.

Upon the roll call, the following Trustees were present:
Trustees Fuentes, Hrejsa, Lazansky, Milenkovic, Savopoulos and White

Trustee Milenkovic moved, duly seconded by Trustee White, to approve the minutes of the previous regular session on Tuesday, May 3, 2016.

Upon the roll call, the following Trustees voted:

Mayor Morelli declared the motion carried.

Trustee White moved, duly seconded by Trustee Savopoulos that the bills, approved by the various committees of the Board, be approved for payment, and to approve warrants which authorize the Village Treasurer to draw checks to pay the bills, to be signed by the authorized signers, as provided for by the Ordinances of the Village of Stickney.

Mayor Morelli declared the motion carried.

Trustee White moved, duly seconded by Trustee Milenkovic to pass and approve Ordinance 2016-14, "An Ordinance Amending Ambulance Fees."

Prior to the vote Trustee Fuentes stated that at the last board meeting we said that we were going to add this to the agenda. She said that she is not opposed to increasing the fees; she just wondered how it jumped from adding it to the agenda to already having the fees set up. Trustee White responded that he got a call from one of the attorneys from Village Attorney Del Galdo's Law Firm asking what we wanted to do about that. Trustee White told him that we needed to get up to speed to be in line with everybody around us with their fees. He then directed him to the Fire Chief. The Chief provided him with the chart that he had with the fees.

Mayor Morelli then introduced Kristen Anzelmo and Don Bettenhausen. The speakers were from Medical Reimbursement Service. Mr. Bettenhausen said that they did look over our rates and they were well below the average of other municipalities' rates. The last increase we did was in 2011. The times are changing and the costs are rising. At MBS Care they do work with the chief. We do serve at the pleasure of the village. Kristen Anzelmo spoke of the higher rates in the surrounding communities. She informed us of the Portable Care Act and those changes. They are seeing a lot of replacement plans. They used to be paid at commercial insurance Blue/Cross Blue/Shield rates that are now Blue Cross/Blue Shield replacement plans that are being paid at Medicaid rates. They feel that it is important that we keep our rates current. Medicare offers between a 2 and 4% increase in their allowables each year. We recommend to our clients that they pass that on so that you always stay current with your rates. We recommended to the Chief that now is the time to get in there to get your rates up to what they should be with the surrounding communities.

A question came from audience member Donald Tabor. He wanted to know what that means to the people of Stickney who call for an ambulance. He was told by Trustee White that residents are not going to be charged. Fire Chief Meyer explained that we take whatever the insurance or Medicare pays. He asked that people call with the balance and they write off whatever is owed. Trustee White further explained that it is for non-residents for an accident.

Trustee Lazansky moved, duly seconded by Trustee White to concur with Mayor Morelli to name Police Chief John Sladetz and Fire Chief Larry Meyer to the position of non-voting members of the Emergency Telephone System Board.

Trustee Lazansky moved, duly seconded by Trustee Fuentes to concur with the appointments to the Parks and Recreation Commission.

Prior to the vote, Trustee Hrejsa wanted to know if they all have been finger printed and had a background check. The Mayor said that it has to be done now. Trustee Hrejsa asked, "Shouldn't it be done before the appointment?" The Mayor said, "These are new people." The mayor asked that Deputy Chief Jaczak talk to them afterwards and tell them what they need to do, although most of them are. The Deputy Chief will set something up with Officer Lochridge.

Mayor Morelli declared the motion carried.

NEW BUSINESS:

Discussion and possible vote regarding a proposed lease agreement with Verizon:

Trustee Savopoulos explained that about three meetings ago we discussed accepting Offer B which was \$3,400.00 monthly rent with at \$1,500.00 signing bonus. But, they revised that offer to \$3,200.00 with a \$1,500.00 signing bonus. He believed that the Metropolitan Water Reclamation will not be getting any of that. Village Attorney Del Galdo informed us that they require a \$5,000.00 annual license fee but not a percentage of the rent for this particular transaction. Village Attorney Del Galdo further explained that we had dealt with Mike Dushaunt from Dolan Realty Advisors. He had agreed to an amount that was subject to his client's approval which was Verizon. Then he went to Verizon and they didn't accept \$3,400.00, but would only accept \$3,200.00 per month. That is why there is a differential than what was discussed three meetings ago and what is on the table currently.

Trustee Savopoulos moved, duly seconded by Trustee Milenkovic to accept the revised offer dated April 19, 2016.

Upon the roll call, the following Trustees voted:

Mayor Morelli declared the motion carried.

Consideration and possible action directing legal counsel to file a demolition action or other legal action related to the property located at 3943 Home Avenue.

Trustee White said that he understood that the person that bought this property agreed to demolish the property after they took possession of it. He went on; "This consideration for action is not for the village to take action to tear this down. " " Is this somehow or another to push them to do what they were supposed to do?" Village Attorney Del Galdo explained, "This was at the request of Dave Schmidt, Building Inspector." "He couldn't be here today so he asked that we write a memo to the board explaining his position." The board was asked if they received that. Village Attorney Del Galdo stated, "The owner signed on August 28, 2015 a letter of agreement for demolition." "This said that they agreed that they would only buy the property on the condition that they would only demolish it." "The village relied upon their signed

statement and issued transfer stamps at the closing." "They now refuse to demolish it." "The matter before you tonight is for discussion." "If you want to take action, you can take action on whether to direct the village to file a demolition action against them." "Which would require the village to demolish it and you would lien the property." Trustee White wanted to know if we have written them a SLO (Stickney Local Ordinance) to the owner on the property for not doing what he was supposed to do. Village Attorney Del Galdo explained, "He could tell us all about the legal process; I don't know what has been done." Trustee White clarified the SLO process. "He is written a SLO and he winds up in court and he doesn't do what he is supposed to do and then we can fine him \$500.00 a day." "Then I think he will do what he is supposed to do rather than the village taking on the expense of tearing down the property." Village Attorney Del Galdo didn't know if he has done that or not. Trustee Savopoulos asked, "We should make a motion to fine him the max." Village Attorney Del Galdo said, "You wouldn't really need to." "This was set for discussion." "I thought you have been briefed." "You can discuss it and take no action, and at the meeting in June. . . . You don't have to do anything to direct him to write tickets on code." "You only need to take action tonight if you want to authorize my office to file a demolition action." Trustee White doesn't want the village to take that on and then get stuck with a demolition and get stuck with an empty lot that is not worth what it the cost us to tear it down. Trustee White went on, "I think if we could write him a SLO to start with and it winds up in court, then our adjudicator, if he doesn't comply, we could fine him up to \$500.00 per day." "That way we will know for sure that he is going to tear it down." Trustee Savopoulos said, "Or we could enforce this agreement that he signed for \$500.00 per day after January." Trustee Lazansky then started reading the signed agreement out loud. He continued by saying that he is sure that Arturo has been writing them SLO's for years. It has been vacant. Trustee White admitted that he goes to the adjudication proceedings frequently and never heard this property called. Trustee Savopoulos told us that this property was purchased in August of last year. Village Attorney Del Galdo admitted, "I don't know all the facts in what has occurred." "On an inspector level, we were asked by Inspector Dave Schmidt to add this to the agenda and they wrote a memo to the board." "I don't know why he wants to go to the drastic remedy of demolition in terms of whether all other efforts in terms of ticketing and liens have failed." "The legal fees would be significant to file a demolition action." Trustee Fuentes asked, "That we move this to the next meeting."

MAYOR'S REPORT: We were told that there will be a Memorial Day program on May 30, 2016. The program will take place on 39th and Ridgeland at the Veteran's Memorial at 10:30 a.m. Following that we will go the Recreation Center at 41st and Home. There will be light snacks, a light lunch.

CLERK'S REPORT: No report

TRUSTEES' REPORTS: Trustee Fuentes informed us that there will be a Parks and Recreation meeting on May 18, 2016 at 6:30 in the board room over by the bathrooms. She referred to information provided to the trustees by Public Works Supervisor, Jeff Boyajian concerning MWRD and effluent water. She asked that this be added to the next agenda. Village Attorney Del Galdo acknowledged that his office

has been waiting for input from the board. Trustee White wanted to make sure that we are protected. Village Attorney Del Galdo will revise it. They frankly didn't want to revise the agreement. The board is required to repeal an ordinance. If you want to move forward, they can propose revisions. He said that there will be impact with this. If there are things that you want that has impact, you can pass it along and they can work it into the agreement.

Trustee Hrejsa mentioned that the Little League parade was last Saturday. She added in that the MWRD open house is May 21.

Trustee Lazansky gave the Police Department Total Monthly Activity Report for the month of April, 2016: Total number of calls for service; 1,602; Total number of E911 calls received; 469; Arrest by type: Traffic: 139; Village Ordinance Offences: 24; Warrants and Complaints: 13; Parking violations: 315; Total number of arrests/citations issued: 491; Total number of squad miles: 10,809; Total amount of gasoline used: 1,235.8; Average gas mileage/squad: 8.747.

Ordinance Activity Report for the month of April, 2016. Ordinance Investigations: 348; Business License Investigations: 5; Violation Notices Issued: 4; Miscellaneous Details: 175; S.L.O. Tickets: 1; Parking Citations Issued: 117; Tow Tag: 1;

Trustee Milenkovic provided us information that the Metropolitan Water Reclamation District has a program called, "Restore the Canopy" where they will be giving away oak saplings every Wednesday from 9:00 a.m. till noon. This is for schools, organizations, neighborhoods or municipalities. At the tour that they will be having this Saturday, they will be giving away individual pots and bulk bags of 100 from 9:00 till noon. In addition, Trustee Milenkovic mentioned that we have all our Tree City USA paperwork submitted. He believed that the ruling would be made in October. He noted that May 21, 2016 is Armed Forces Day.

Trustee Savopoulos reminded us that about a month ago he reported that the Metropolitan Water Reclamation District and the DEA held a drug collection. It was a success. Between April 29-30, they collected 457 pounds of drugs. Therefore, they will have permanent boxes at their locations. They will be available seven days a week from 9:00 a.m. to 6:00 p.m.

Trustee White thanked our fire chief. He has reported in the past the attempt to receive grants for air packs for our fire department. They are aging and expensive to keep them up to a safety standard. Last year the grant was denied. He reapplied for the grant and did receive a \$160,000.00 grant. The way he comprehends it, the village is only obligated for an additional \$8,000.00.

Trustee White moved, duly seconded by Trustee Savopoulos to accept the treasurer's report for the month of February, 2016.

Upon the roll call, the following Trustees voted:

Nays: None

Mayor Morelli declared the motion carried.

DEPARTMENT REPORTS: Deputy Chief Rich Jaczak informed us that he just attended a meeting in Countryside concerning the meeting/hearing on the I-55 Managed Lane Project. Excluding what is currently happening on First Avenue now and the additional traffic here, over 150,000 vehicles travel over our roads in the Village of Stickney every single day. It looks like the I-55 Managed Lane Project is going to go through. There is going to be a toll lane going through 355 to 90/94. There will be no exits. You will pay at 355 and get through. They are hoping that this eliminates the traffic and congesting that will hit our streets also as being just north of I-55. It is not funded by taxpayers. Whoever operates the toll lane will fund the entire project. He is hoping that this goes through. In addition, he told us that on May 8th our dispatch got a call that there was a fire at Las Fuentes Restaurant at 8:30 a.m. Our officers were on the scene. The fire department arrived soon after. It was found that someone lit an intentional fire at Las Fuentes. Detective McGuire was called in, he is a certified arson investigator, along with Tommy Heller from the fire department. There was a suspect interrogated. They did file arson charges against her. It is a Class II felony that could face years in jail. As far as anyone in the police department could remember, it was the first arson arrest made.

We also were informed that he is going to get our Emergency Telephone Systems Board within the next week or so to discuss the consolidated dispatch. He mentioned that he will need a resolution from the board to submit a waiver. A waiver is only kicking the can down the road. It is not a permanent solution. It will give us a waiver for three or five years. During that time we will have to budget to set money aside. If the waiver is denied, it will be financially draining for the village. The *Landmark Newspaper* announced that Brookfield, Riverside and North Riverside just came to an agreement to consolidate their dispatch centers. They acknowledge that they won't save any money for at least ten years. They still have no idea how much it is going to cost them. The Deputy Chief will be submitting a waiver, assuming that the Emergency Telephone Systems Board and the Village Board is in favor of it, based on it being financially infeasible and also public safety. He said that in 2009 he was the watch commander on afternoons when a gentleman ran into our lobby after being stabbed in his throat. He couldn't speak. He could never pick up a phone to connect with a dispatch center 15 miles away. He stood there. The dispatcher contacted the fire department. Then the police came in. We arrested someone for attempted murder. Secondly, our police department by state law is a Safe Haven. Someone could drop off a one-week-old child in front of our station and walk away without criminal charges being filed. We don't have someone in that dispatch center or lobby overnight, our police officers enter and leave the building at the side entrance where it is quicker and convenient. Public Safety is the second aspect as to why he is asking for a waiver. It will have to be done at the next meeting. It is due July 1, 2016. We have to have it submitted before that. If we don't get a waiver, we can talk to various entities about consolidating with them. There is no good option, but we will have to decide what the best option is. He added that there are some villages that are simply not complying. They are not submitting a waiver. They are not consolidating. They are just going forward. There is no clear punishment has been laid out yet. We were also told that our Ordinance Control Officer, Arturo Terrazas has been writing tons of notice of violations tickets.

Fire Chief Larry Meyer provided us news concerning the grant. It is a lot of money. Our required \$8,000.00 is 5% of the money. He explained that on last Friday he received an 1199A form. There were other specifics that will be required. He told us that they will be receiving 24 air packs with the money. They are somewhere around \$6,000.00 apiece. When his application was denied last year, he wasn't told why. He asked a consultant to look at it. He resubmitted the application just like it was. We got it this year. Our current air packs are 14-years- old. They have a 10 year warranty. But, repairs for the electronics are expensive.

TREASURER'S REPORT: Kurt Kasnicka reminded us that the administrative offices will be closed on Memorial Day. Garbage collection will be one day behind. Our office is preparing the vehicle sticker and animal license applications to be mailed out at the end of the month. They will go on sale on June 1. He asked that people buy their stickers and licenses early.

There being no further business, Trustee White moved, duly seconded by Trustee Savopoulos that the meeting be adjourned. Upon which the Board adopted the motion at 7:45 p.m.

Re: Waive the sealed bid process and approve emergency purchase of computer equipment and software for the Stickney Water Pumping Station.

In mid-May the pumping station was hit by a lightning strike, which caused a catastrophic failure of the electronics and computer system that run all the systems at the pump station, which we are doing manually now. There is no way to monitor remotely what the status at the pump station real time. We were looking at upgrading the system prior to this occurring. To fix the existing system would be too costly to fix.

Due to the inability to monitor and control remotely, I am requesting to having all equipment replaced under emergency status and waiving the sealed bid process. I am requesting to spend an amount of \$81,230 and \$3,370 in incidentals if needed. We have been in contact with our Village Engineer Tim Geary and one of his associates John Kuebrich, who both recommended the following company to perform the work. Both myself, and Water Operator Robert Wyant agree that this is the way we should move forward on.

Recommendation:

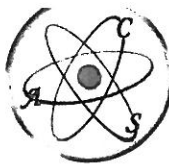
We request waiving the sealed bid process and approve and award project to Automatic Control Services in the amount not to exceed \$85,000 which includes incidentals.

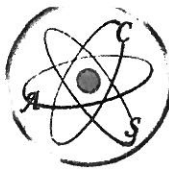

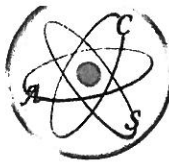

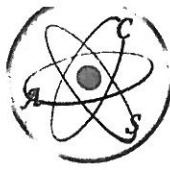

ORDINANCE NO. 2016-15

AN ORDINANCE ESTABLISHING THE PREVAILING WAGE RATES FOR THE CONSTRUCTION OF PUBLIC WORKS PROJECTS FOR THE VILLAGE OF STICKNEY

WHEREAS, the Village of Stickney (the "Village") is a home rule municipal corporation in accordance with Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970; and

WHEREAS, the Village has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs, and to review, interpret and amend its ordinances, rules and regulations; and

WHEREAS, the State of Illinois has enacted the Prevailing Wage Act (820 ILCS 130/0.01, *et seq.*) (the "Act"), which regulates the wages of laborers, mechanics and other workers employed in any public works by the state, county, city or any public body or political subdivision or by anyone under contract for public works projects; and

WHEREAS, the Act requires the Village to investigate and ascertain the prevailing rate of wages, as defined in the Act, for laborers, mechanics and other workers in the locality of the Village employed in performing the construction of public works projects for the Village; and

WHEREAS, due to the state budget crisis, the Illinois Department of Labor ("IDOL") has not issued revised prevailing wage rates for laborers, mechanics and other workers performing the construction of public works projects for this year; and

WHEREAS, IDOL's most current prevailing wage rates were issued for July of 2015; and

WHEREAS, in order to provide adequate notice to Village workers and residents, the Village President (the "President") and the Board of Trustees of the Village (the "Village Board" and with the President, the "Corporate Authorities") have determined that it is in the best interests of the Village to adopt IDOL's most current revised prevailing rate of wages for the construction of public works projects in the Village (the "Determination"), attached hereto and incorporated herein as Exhibit A;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, as follows:

ARTICLE I. IN GENERAL

SECTION 1. INCORPORATION CLAUSE.

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preambles to this Ordinance are full, true and correct and do hereby, by reference, incorporate and make them part of this Ordinance as legislative findings.

SECTION 2. PURPOSE.

The purpose of this Ordinance is to establish the prevailing wage rates for the construction of public works projects in the Village, in accordance with the Act and the Determination.

ARTICLE II. AUTHORIZATION

SECTION 3. AUTHORIZATION.

To the extent and as required by the Act, the general prevailing rate of wages in the Village for laborers, mechanics and other workers engaged in the construction of public works projects coming under the jurisdiction of the Village is ascertained to be the same as the prevailing rate of wages for construction work within the Cook County, Illinois, area, as determined by IDOL as of July 2015. The definition of any terms appearing in this Ordinance that are also used in the Act shall be the same as in the Act. As required by the Act, any and all revisions of the prevailing rate of wages made by IDOL shall supersede the Village's current Determination for the construction of public works projects in the Village. Nothing herein shall be construed to apply the general prevailing rate of wages as herein ascertained to any work or employment except public works of the Village to the extent required by the Act.

SECTION 3.01. OTHER ACTIONS AUTHORIZED.

The Village Clerk or a designee of the same is hereby authorized and directed to: (a) publicly post, or keep available for inspection by any interested party in the main office of the Village, the Determination; (b) promptly (and in no event later than July 15, 2016) file a certified copy of this Ordinance and the Determination in the office of IDOL; and (c) within thirty (30) calendar days after filing with IDOL, publish in a newspaper of general circulation within the Village that the Determination is effective, publish a notice of the Determination and promptly mail a copy of the Determination to any employer, to any association of employers and to any person or association of employees who have filed or who file their names and addresses, requesting copies of any determination, stating the particular rates and the particular class of workers whose wages will be affected by such rates. The officers, employees and/or agents of the Village shall take all action necessary or reasonably required to carry out, give effect to and consummate the intent of this Ordinance and shall take all action necessary in conformity therewith. The officers, employees and/or agents of the Village are specifically authorized and directed to draft and disseminate any and all necessary forms to be utilized in connection with this Ordinance.

ARTICLE III. HEADINGS, SAVINGS CLAUSES, PUBLICATION, EFFECTIVE DATE

SECTION 4. HEADINGS.

The headings of the articles, sections, paragraphs and subparagraphs of this Ordinance are inserted solely for the convenience of reference and form no substantive part of this Ordinance nor should they be used in any interpretation or construction of any substantive provision of this Ordinance.

SECTION 5. SEVERABILITY.

The provisions of this Ordinance are hereby declared to be severable and should any provision of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable and as though not provided for herein and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

SECTION 6. SUPERSEDER.

All code provisions, ordinances, resolutions, rules and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

SECTION 7. PUBLICATION.

A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

SECTION 8. EFFECTIVE DATE.

This Ordinance shall be effective and in full force immediately upon passage and approval.

EXPLANATION OF CLASSES

ASBESTOS - GENERAL - removal of asbestos material/mold and hazardous materials from any place in a building, including mechanical systems where those mechanical systems are to be removed. This includes the removal of asbestos materials/mold and hazardous materials from ductwork or pipes in a building when the building is to be demolished at the time or at some close future date.

ASBESTOS - MECHANICAL - removal of asbestos material from mechanical systems, such as pipes, ducts, and boilers, where the mechanical systems are to remain.

CERAMIC TILE FINISHER

The grouting, cleaning, and polishing of all classes of tile, whether for interior or exterior purposes, all burned, glazed or unglazed products; all composition materials, granite tiles, warning detectable

tiles, cement tiles, epoxy composite materials, pavers, glass, mosaics, fiberglass, and all substitute materials, for tile made in tile-like units; all mixtures in tile like form of cement, metals, and other materials that are for and intended for use as a finished floor surface, stair treads, promenade roofs, walks, walls, ceilings, swimming pools, and all other places where tile is to form a finished interior or exterior. The mixing of all setting mortars including but not limited to thin-set mortars, epoxies, wall mud, and any other sand and cement mixtures or adhesives when used in the preparation, installation, repair, or maintenance of tile and/or similar materials. The handling and unloading of all sand, cement, lime, tile, fixtures, equipment, adhesives, or any other materials to be used in the preparation, installation, repair, or maintenance of tile and/or similar materials. Ceramic Tile Finishers shall fill all joints and voids regardless of method on all tile work, particularly and especially after installation of said tile work. Application of any and all protective coverings to all types of tile installations including, but not be limited to, all soap compounds, paper products, tapes, and all polyethylene coverings, plywood, masonite, cardboard, and any new type of products that may be used to protect tile installations, Blastrac equipment, and all floor scarifying equipment used in preparing floors to receive tile. The clean up and removal of all waste and materials. All demolition of existing tile floors and walls to be re-tiled.

COMMUNICATIONS ELECTRICIAN

Installation, operation, inspection, maintenance, repair and service of radio, television, recording, voice sound vision production and reproduction, telephone and telephone interconnect, facsimile, data apparatus, coaxial, fibre optic and wireless equipment, appliances and systems used for the transmission and reception of signals of any nature, business, domestic, commercial, education, entertainment, and residential purposes, including but not limited to, communication and telephone, electronic and sound equipment, fibre optic and data communication systems, and the performance of any task directly related to such installation or service whether at new or existing sites, such tasks to include the placing of wire and cable and electrical power conduit or other raceway work within the equipment room and pulling wire and/or cable through conduit and the installation of any incidental conduit, such that the employees covered hereby can complete any job in full.

MARBLE FINISHER

Loading and unloading trucks, distribution of all materials (all stone, sand, etc.), stocking of floors with material, performing all rigging for heavy work, the handling of all material that may be needed for the installation of such materials, building of scaffolding, polishing if needed, patching, waxing of material if damaged, pointing up, caulking, grouting and cleaning of marble, holding water on diamond or Carborundum blade or saw for setters cutting, use of tub saw or any other saw needed for preparation of material, drilling of holes for wires that anchor material set by setters, mixing up of molding plaster for installation of material, mixing up thin set for the installation of material, mixing up of sand to cement for the installation of material and such other work as may be required in helping a Marble Setter in the handling of all material in the erection or installation of interior marble, slate, travertine, art marble, serpentine, alberene stone, blue stone, granite and other stones (meaning as to stone any foreign or domestic materials as are specified and used in building interiors and exteriors and customarily known as stone in the trade), carrara, sanionyx, vitrolite and similar opaque glass and the laying of all

marble tile, terrazzo tile, slate tile and precast tile, steps, risers treads, base, or any other materials that may be used as substitutes for any of the aforementioned materials and which are used on interior and exterior which are installed in a similar manner.

MATERIAL TESTER I: Hand coring and drilling for testing of materials; field inspection of uncured concrete and asphalt.

Class 2. The handling of sand, cement, marble chips, and all other materials that may be used by the Mosaic Terrazzo Mechanic, and the mixing, grinding, grouting, cleaning and sealing of all Marble, Mosaic, and Terrazzo work, floors, base, stairs, and wainscoting by hand or machine, and in addition, assisting and aiding Marble, Masonic, and Terrazzo Mechanics.

TRAFFIC SAFETY

Work associated with barricades, horses and drums used to reduce lane usage on highway work, the installation and removal of temporary lane markings, and the installation and removal of temporary road signs.

TRUCK DRIVER - BUILDING, HEAVY AND HIGHWAY CONSTRUCTION - EAST & WEST

Four axle trucks; Dump Crets and Adgetors under 7 yards; Dumpsters, Track Trucks, Euclids, Hug Bottom Dump Turnapulls or Turnatrailers when pulling other than self-loading equipment or similar equipment under 16 cubic yards; Mixer Trucks under 7 yards; Ready-mix Plant Hopper Operator, and Winch Trucks, 2 Axles.

Class 3. Five axle trucks; Dump Crets and Adgetors 7 yards and over; Dumpsters, Track Trucks, Euclids, Hug Bottom Dump Turnatrailers or turnapulls when pulling other than self-loading equipment or similar equipment over 16 cubic yards; Explosives and/or Fission Material Trucks; Mixer Trucks 7 yards or over; Mobile Cranes while in transit; Oil Distributors, 1-man operation; Pole Trailer, over 40 feet; Pole and Expandable Trailers hauling material over 50 feet long; Slurry trucks, 1-man operation; Winch trucks, 3 axles or more; Mechanic--Truck Welder and Truck Painter.

Class 4. Six axle trucks; Dual-purpose vehicles, such as mounted crane trucks with hoist and accessories; Foreman; Master Mechanic; Self-loading equipment like P.B. and trucks with scoops on the front.

Other Classifications of Work:

For definitions of classifications not otherwise set out, the Department generally has on file such definitions which are available. If a task to be performed is not subject to one of the classifications of pay set out, the Department will upon being contacted state which neighboring county has such a classification and provide such rate, such rate being deemed to exist by reference in this document. If no neighboring county rate applies to the task, the Department shall undertake a special determination, such special determination being then deemed to have existed under this determination. If a project requires these, or any classification not listed, please contact IDOL at 217-782-1710 for wage rates or clarifications.

LANDSCAPING

Landscaping work falls under the existing classifications for laborer, operating engineer and truck driver. The work performed by landscape plantsman and landscape laborer is covered by the existing classification of laborer. The work performed by landscape operators (regardless of equipment used or its size) is covered by the classifications of operating engineer. The work performed by landscape truck drivers (regardless of size of truck driven) is covered by the classifications of truck driver.

MATERIAL TESTER & MATERIAL TESTER/INSPECTOR I AND II

Notwithstanding the difference in the classification title, the classification entitled "Material Tester I" involves the same job duties as the classification entitled "Material Tester/Inspector I". Likewise, the classification entitled "Material Tester II" involves the same job duties as the classification entitled "Material Tester/Inspector II".
