The Board of Trustees of the Village of Stickney met in regular session on Tuesday, December 4, 2012 at 7:00 p.m. in the Stickney Village Hall, 6533 W. Pershing Road, Stickney, Illinois.

Upon the roll call, the following Trustees were present: Present: Trustees Horne, Morelli, Savopoulos, Walik, White and Zeedyk

Trustee Walik moved, duly seconded by Trustee Savopoulos, to approve the minutes of the previous regular session on Tuesday, November 20, 2012.

Upon the roll call, the following Trustees voted: Ayes: Trustees Morelli, Savopoulos, and Walik Present: Trustees Horne and Zeedyk Nays: None President O'Reilly declared the motion carried.

Trustee Morelli moved, duly seconded by Trustee Horne that the bills, approved by the various committees of the Board, be approved for payment, and to approve warrants which authorize the Village Treasurer to draw checks to pay the bills, to be signed by the authorized signers, as provided for by the Ordinances of the Village of Stickney.

Upon the roll call, the following Trustees voted: Ayes: Trustees Horne, Morelli, Savopoulos, Walik, White and Zeedyk Nays: None President O'Reilly declared the motion carried.

Trustee Walik moved, duly seconded by Trustee White to approve Engineer's Payment Estimate No. 2, for Street Rehabilitation Phase 6 MFT Section No. 12-00057-00-RS for the sum of \$198,239.00.

Upon the roll call, the following Trustees voted: Ayes: Trustees Horne, Morelli, Savopoulos, Walik, White and Zeedyk Nays: None President O'Reilly declared the motion carried.

Trustee Savopoulos moved, duly seconded by Trustee Walik to pass and approve Ordinance 2012-17, "The 2012 Tax Levy Ordinance for the Fiscal Year Beginning May 1, 2012 and ending April 30, 2013.

Upon the roll call, the following Trustees voted: Ayes: Trustees Horne, Morelli, Savopoulos, Walik, White and Zeedyk Nays: None President O'Reilly declared the motion carried.

Trustee Savopoulos moved, duly seconded by Trustee Horne to pass and approve Ordinance 2012-18, An Ordinance Amending Water Rates and Charges."

Upon the roll call, the following Trustees voted: Ayes: Trustees Horne, Morelli, Savopoulos, Walik, White and Zeedyk Nays: None President O'Reilly declared the motion carried.

President O'Reilly explained prior to the vote that last year we passed on the rates that were passed on to us from Chicago for the 25%, 15%, 15% and 15%. With the changes we have made and improvements to the water system with the some of the meters on the east end, we are in good shape with the water fund. We don't need to pass on this year's 15%. What this ordinance does is to amend it. There will be no increase in the water rates this year.

Trustee Walik moved, duly seconded by Trustee Savopoulos to approve the proclamation proclaiming December as National Drunk and Drugged Driving Prevention Month.

Upon the roll call, the following Trustees voted: Ayes: Trustees Horne, Morelli, Savopoulos, Walik, White and Zeedyk Nays: None President O'Reilly declared the motion carried.

Trustee Morelli moved, duly seconded by Trustee Horne to grant permission to the Girl Scouts of Greater Chicago and Northwest Indiana to conduct their cookie order program January 5-25, 2012.

Upon the roll call, the following Trustees voted: Ayes: Trustees Horne, Morelli, Savopoulos, Walik, White and Zeedyk Nays: None President O'Reilly declared the motion carried.

Prior to the vote, President O'Reilly explained that they have satisfied their liability insurance and hold harmless agreement.

TRUSTEES REPORTS: Trustee Morelli gave the report for the month of November, 2012 Fire Department activity. Calls: There were 94 calls as follows: 58 ambulance calls, 9 service calls, 14 mutual automatic aid to another town calls, 9 automatic trouble fire alarms and 4 vehicle accidents. In the year of 2012 the Stickney Fire Department has responded to a total of 1198 calls.

Trustee Zeedyk gave the police report for the month of November, 2012. The total number of calls for service: 1,765, Total number of E911 calls received: 388, Arrest by type: Traffic: 132, Village Ordinance Offences: 10, Warrants and Complaints: 9, Parking violations: 157, Total number of arrests/citations issued: 308, Total number of squad miles: 10,434, Total amount of gasoline used: 983, Average gas mileage/squad: 10.7 mpg.

DEPARTMENT REPORTS: Fire Chief Larry Meyer praised the efforts of Chief Engineer Donald Kerbs who recently completed the course work for Emergency Vehicle Technician Certification. This is a National Fire Protection Association certification. His studies included a test covering ambulance design, ambulance electrical systems, fire apparatus design and fire apparatus electrical systems. This type of certification is now mandated for anyone who works on or repairs this type of equipment. We have our own in-house-guy for that. He should be commended for this achievement.

There being no further business, Trustee Zeedyk moved, duly seconded by Trustee Walik that the meeting be adjourned. Upon which the Board adopted the motion at 7:08 p.m.
