TERMS AND CONDITIONS FOR ISSUANCE. NO SPECIAL PERMIT WILL BE ISSUED UNLESS THERE IS FULL COMPLICANCE WITH THE FOLLOWING TERMS AND CONDITIONS.

THE APPLICANT-PERMITEE MUST BE THE OWNER OF THE PREMISES WHERE SALE IS TO BE HELD.
